Mr. Roderick stated that this year they would like to have a small parade from Lopes field to the Pier. He would also like to use the parking lot located that borders CW Bishop, Highland Ave $\&~10^{th}$ Ave for the purpose of parking motorcycles.

a. Sewer tie in - 4 Dusty Lane

Mr. Campinha was before the board. The property was recently purchased and the homeowner is looking to tie in to the system due to his failed septic system.

MOTION: Selectman Winslow moved to approve the application for a sewer connection for 4 Dusty Lane made by Roland Michaud and Alan Rivers. Selectman Begley seconded.

b. Policy update

Mr. Campinha stated that he met with Selectman Begley and they are working on some polices and he is in the process of doing some updates and will have them for the board next week.

c. Set date for public meeting (contract 2)

The board asked Mr. Campinha to put together a packet on how the sewer betterment is achieved, timeline as to the betterment, explain the cost of the betterment in detail and also asked that these packets go out prior to the meeting with the residents. Chairman Holmes also asked that Mike Guidice, Tom Casey, Marc Deshaies, and a Representative from the Police to be available for the meeting. Chairman Holmes asked that Mr. Camphina provide the board with a draft by June 1st, final by June 8th and distribution of information by June 22nd.

d. Any other sewer business

Mr. Camphinha spoke about an issue with grease in the sewer system from a business in the industrial park. He has asked to get on the Board of Health's agenda to have them assist them. He is also going to work on grease policy.

Selectman Begley asked Mr. Camphina to speak about the issue with the mitigation with the berm done and the town being charged \$5000. Mr. Camphina stated the charge was removed on contract 2, he told Mr. Guidice that the town isn't paying.

Mr. Camphina stated that the Cromesett pump station is taking on water. He suggested to the board they do not accept the project until that is taking care of otherwise, they will own it. Chairman Holmes asked that in the future that they he sends along an email with the issues so they can be placed on the agenda and not under any other sewer business.

9. TOWN BUSINESS

a. Route 6 & 28 Reconstruction presentation

Present before the board: Carrie Lavallee, Project Manager, Pam Hasner and Mr. Hatfield from SRPEDD

Ms. Lavallee gave a brief update on the project. She said the next step is to hold a public hearing which has been set for July 12th at 7pm in the Town Hall Cafeteria. She said that they will be advertising this hearing and will have a handout as well. The current cost is about \$10.5 million dollars and due to the cost of the project it would have been done over two fiscal years. Ms. Lavallee said the process would be holding the hearing, get feedback and then they start the right of way process. They have asked at this point to have the project pushed to FY2015 & FY2016. The project would need to be spread over two years due to the cost. The plans

from Mass DOT are to discontinue the road after the project but they would also consider some options such has plowing for a certain number of years. Chairman Holmes asked what could be done to get this project moving forward. Ms. Hasner stated they should attend JTPG & MPO meetings to support the project. Ms. Lavallee said that it would be helpful to have the Selectmen along with fire and rescue who are support as well.

- b. Review Town Administrators Job Description
 The board will review this next week to allow time to look over the posting document.
- c. Dog by-law committee appointment
 A motion was made to amend the by-law article at town meeting to put in place a
 dog by-law committee. The Appointing Authority appointed Walter B. Cruz, Sr.,
 Kenneth Levett and Manfred Weingandt. Also needed was one member from the
 board of Selectmen

Selectman Winslow moved that Selectman Teitelbaum serve as the MOTION: Board of Selectmen's member to the dog by-law committee. Selectman Slavin seconded for discussion. Selectman Begley wanted to address a letter received and read into the record (as attached) from Judy Weatherby, 59 Oak Street regarding Selectmen's Teitelbaum's dogs and feels he cannot have an unbiased decision on any by-laws. Selectman Teitelbaum responded to the letter he said that it was true that one of his dogs did go over the fence and did order parts, which took a couple of days to come in. He stated that his dog in the meantime did jump over the fence and approached a cocker spaniel being walked by his owner and he said that he did go to the owner and insisted that she take the dog to the vet. He said that he did pay the vet bill immediately and took care of the escape issue. He said that their has been German Shepherds at that property for 16 years and the Saturday in April that the letter writer refers to was the first time that he has ever heard from Animal Control regarding barking dogs. He said that she informed him that she had six complaints and believes that two have come from the same person. He did canvass the neighbors and said that someone did say they called and that the dogs have been bothering them for some time and he asked why they didn't say something years ago? They said that they have called animal control in the past and nothing was ever done. He said that what he feels the letter states is that when he is confronted with a dog problem he deals with it and is a responsible dog owner. Selectman Begley stated that she has a problem since Selectman Teitelbaum's dogs are nuisance barkers and that another dog did have puncture wounds from his dog.

Selectman Winslow asked if discussion of ballot questions could be placed on an agenda rather quickly. Chairman Holmes said that he did receive a letter from the School Department to attend for a presentation.

10. TOWN ADMINISTRATOR'S REPORT

Update Earth Removal fee collection status

Mr. Foster said a letter was sent out to Mr. Grazanio about overdue earth removal fees in the amount of \$24,479. The bill was mailed out on May 14, 2012.

Discuss recycling committee budget

Mr. Foster asked Mr. Sullivan to come before the board to answer Selectman Begley's question. She asked if the Town contributes \$5000 and it costs \$11,000 to run the recycling center where are the funds coming from? Mr. Sullivan said they have revenues from donated cans, bottles, batteries, etc...in FY10 they had revenues of \$2973, FY11 \$4,047, FY12 they are estimating \$3,579. He said that this year they did receive an additional grant of \$1250. They are projecting in March they would run out of funds. Selectman Begley said that most of their expense is for renting the containers. Mr. Sullivan said that have asked for an additional \$3000. Chairman Holmes asked if anyone wants to donate \$3000 for the recycling center it would be appreciated.

Mr. Foster has received a letter from Wareham Village Association to use part of Besse Park for a pumpkin patch to plant seeds in the tilled ground or raised bed. They would like to have family's plant seeds in May and harvest in October. He said that he contacted Town Counsel who has drafted a standard license agreement to use for this type of request. Mr. Foster provided a copy to the board. Selectman Winslow asked if this could be placed on the next agenda.

Mr. Foster asked if anyone had any interest in serving on the screening committee for the building and local plumbing positions.

MOTION: Selectman Winslow moved that Chairman Holmes continue on the local building and local plumbing screening committee. Selectman Teitelbaum seconded.

VOTE: 5-0-0 (Unanimous)

Chairman Holmes said perhaps next week Mr. Foster can have Justin Cole come in and give a report on the reconciliation. Mr. Foster stated that at the last

Department Head meeting he discussed year-end budgets and all departments were asked to cease all non-essential spending. Coming into the end of this fiscal year, if they were promised any transfers or anything out of line in their budgets they were asked to let Mr. Foster know. Selectman Begley spoke about the posting of positions with the town
