- b. Funding source for contract 2
  Selectman Begley went over the figures for contract #2. The total cost of the project was 5,847,133.89, number of properties were 274, which the total cost of the betterment is \$21,339.90. The betterment approved at town meeting was capped at \$18,000, which leaves a difference of \$3,339.90 per property for a total deficit of \$915,132.60. Mr. Sullivan will speak with someone at the DOR to find out what the appropriate process is to address the deficit. Attorney Bowen will look into whether or not the \$3.339.90 amount is considered possible income.

a. Machine surplus request – 1993 Backhoe excavator

This machine is being traded in to purchase a newer machine.

**MOTION:** Selectman Begley moved to approve the surplus request for the vehicle described to be used for the acquisition of a 2012 John Deere mini excavator (1) 1993 JCB 214S site-master 4wd backhoe excavator serial # USA214SOCPE412088. Selectman Teitelbaum seconded.

Mr. Sullivan spoke about a complaint received from the Police Department regarding a restaurant that has closed and have not notified the board. At this time the establishment has not come in to renew the application for next year. The Board asked Mr. Sullivan to check on the status of two establishments owned by this individual and report back to the board at the next meeting.

Mr. Sullivan said that the auditors have left and the DOR will be hearing directly from them. He also stated that the DOR has approved the LA3, LA4 & LA13 forms from the Assessor's Department, which is a major step in setting the tax rate. The balance sheet should be ready by the end of the week by the Accounting office.

Mr. Sullivan stated that EMS was called to a home on November 22<sup>nd</sup> and upon arrival Wareham EMS paramedics Cheryl Evans and Brian Donahoe responded to a

maternity call. On arrival they found the woman in her bedroom and during the exam she delivered a baby boy!

Selectman Begley asked when the Town Accountant position would be posted? Mr. Sullivan said he wouldn't post this until after the 1st of the year so that the tax rate will be set.

Selectman Slavin asked about the payments for the Earth Removal being done by Graziano? Mr. Sullivan will email an update to the Board.

Selectman Teitelbaum asked Mr. Sullivan if he had the personnel in place in the Accounting office until he hires an Accountant? Mr. Sullivan stated that yes he does and he has made sure that it's staffed properly.

#### 11. **LIAISON REPORTS**

Selectman Slavin said that .75% meals tax is now sitting in the 3<sup>rd</sup> reading and Susan Williams Gifford's office is working on it.

Selectman Begley stated that the transportation action committee met and an RFP will be going out for four levels of service.
