1. CALL MEETING TO ORDER BY CHAIRMAN

Chairman Holmes called the meeting to order

7. TOWN BUSINESS

Eagle Scout project update

Present before the board: Joseph Lazarus

Mr. Lazarus spoke about the project he completed at the Agawam Cemetery. He painted the gates, weeded the cemetery and also replaced the "M" at the arch of the entrance. He learned how to mix cement and repair the wall that was in need of repair. He thanked the Board of Selectmen, Municipal Maintenance, Cemetery Commission, also all the volunteers that helped which included fellow Boy Scouts, classmates from his current school as well as his middle school, friends, aunts, uncles and his Grandmother. He did also thank Hi-way concrete for their donation of cement. Mr. Lazarus then provided the board with a presentation on the completed project.

b. After Action Report

<u>SELECTMEN/SEWER COMMISSIONERS MEETING - 2-26-13</u> (CONT'D)

Present before the board: Guy Campinha, Mark Gifford, Lt. Walsh, Chief Stanley, Lt. Walcek, Chief McDuffy, Assistance Fire Chief Haskell, Chief Andersen. Dennis Galvin, Nstar Rep.

Chief Stanley thanked the staff and the people who volunteered during the blizzard. He also said they are working on getting a generator at a reduced cost.

Lt.. Walcek spoke about the conference calls and staying in contact with MEMA and explained that the state opened regional centers on an as needed basis and spoke about the warming center that was opened at the Multi-Service Center. Lt. Walcek spoke about the Vice President at Southcoast calling him and stating that they have had many cases of people with hypothermia. He said that the real concern they had was for people without power in the mobile home parks and that 35 soldiers did go and check over 600 mobile homes to make sure that people were safe.

Chief Andersen said that the Municipal Maintenance crew worked well with the Fire Department, if they heard on the scanner about an emergency they made sure the street was plowed to allow the fire and police to get there.

Lt. Walsh stated that from the hours of 7:30am Friday to Midnight Sunday the police took 2438 calls. These calls were answered by two communication officers and an around the clock police officer.

Dennis Galvin from Nstar said that they start preparing before the storm arrives by reaching out to dozens of states as well as Canada. He did say that it's important to call 1-800-592-2000 to report any outages so they can keep a log. He spoke about many of the transmission lines being down.

Mark Gifford first thanked his staff and thanked them for their dedication and said that Mary Healey in his office handled hundreds of complaints. He also thanked Patrick Murphy and Kevin Hunt for working the shelter. Mr. Gifford also spoke about the cost of plowing and sanding and spoke about tree removal. The cost for the hired plows was \$118,000 and said that they had approximately 150 downed trees and he had 17 municipal maintenance workers. The crew used 640 tons of salt at a cost of \$32,000 and 960 tons of sand at a cost of \$9500 and fuel for the two days cost \$6800 for diesel and \$1130 for gas. Mr. Gifford said that the payroll for the two days were \$20,954.

Chief Stanley stated that they have complied all the cost of the storm and have submitted it to FEMA.

Mr. Campinha spoke about the pumping stations and that 6 generators need to be replaced.

SELECTMEN/SEWER COMMISSIONERS MEETING - 2-26-13 (CONT'D)

Chief McDuffy said that his department met prior to the storm to identify the needs and preparations. He spoke about having to call in all his staff and said that they had many alarms to report to as well as major medical calls. Chief McDuffy wanted to thank the families of his staff that are left behind while their loved ones report to work.

Chief Andersen said that he does realize that the budget is tight but they had to address some issues. He said that Nstar stepped up to the plate and the Hydro Quebec crew worked very hard in the Onset area. He said that all the departments worked well together. Chief Andersen wanted to also express his gratitude to all the personnel at Onset Fire & Water Department.

c. Digital Recording – Policy 11-01
Selectman Winslow was looking to suspend this policy until something can be worked out to have enough recorders available. She said that at times people attempt to get a recorder and they are all out and the Chair's of the committees are left with wondering if they should hold a meeting and feel they wouldn't be in compliance. Selectman Teitelbaum asked Attorney Bowen with the open meeting law does the meetings needs to be taped? Attorney Bowen stated that they don't need to tape the meetings they just need to take minutes. Selectman Slavin stated that this policy originated because of him and it was set up so that people could listen to the tapes and he said that the minutes should cover it. Chairman Holmes said that when the meeting is taped it's easier for them to go back and listen to the tape to transcribe the minutes. He said the policy was set up so that the tape would be available until the minutes are voted on and accepted by that committee.

MOTION: Selectman Winslow moved to temporarily suspend policy #11-01 Digital recording and will ask Mr. Sullivan to present a plan in which the policy can be enforced. The board reserves the right to make amendments to the policy including the storage piece no later than April 30, 2013. Selectman Teitelbaum seconded.
