## 8. TOWN BUSINESS

- a. Discussion on guidance to Town Administrator for the next year Selectman Whiteside said that she was very impressed with the rapport that Mr. Sullivan has with the Department Heads as well as elected officials. She feels that cameras should be placed at hot spots where people go through the stop signs and traffic lights and this would bring in some revenue. Selectman Tropeano asked how Mr. Sullivan stood on working with the presentation for Thursday? Mr. Sullivan stated that he did meet with Dr. Rabinovitch and went over numbers and Dr. Rabinovitch will be meeting with his School Committee. Selectman Slavin stated that they have some very tough decisions to make with cutbacks. Selectman Teitelbaum said that he agrees it's going to be difficult to maintain the level of service in the town.
  - b. Discussion on budget for FY14
- c. Discussion re: Payment for earth removal from Highland, Inc. The board discussed payments made by Highland Inc on the earth removal. Mr. Sullivan said that they have attached a 1995 excavator with a value of \$60,000 so if they do default on the payments, then the town would own the piece of equipment. Attorney Bowen
- d. Discussion and possible vote on the Transportation Bid Award The School Department was looking to purchase 2 full sized school buses in the amount of \$70,000.

**MOTION:** Selectman Slavin moved to allow the Town Administrator as Procurement Officer to sign the contract to purchase 2 school buses in the amount of \$70,000. Selectman Whiteside seconded.

e. Vote on seasonal soft-shell clamming areas
The Harbormaster asked the board to take action to affirm the seasonal soft-shell clamming areas. Selectman Whiteside expressed some concern about the opening of the Stony Point Dike area since it was Federal property.

**MOTION:** Selectman Slavin moved that the soft shell clamming seasonal areas in accordance with section III of the Rules and Regulations for the taking of shellfish, eels and sea worms, the Board of Selectman shall close all areas to the

taking of soft-shell clams, from June 1, 2013 through September 15, 2013 except for the following areas - Areas open Monday-Saturday 1. Warren Point westerly to the eastern corner of management area #3 (67 Towhee Rd) 2. Stony Point Dike (where lawful). 3. Widows Cove/Bass Cove. 4. Southern tip of Burgess Point to Codman's Point. 5. Wickets Island 6. The northerly point of Lydia's Island to the Western end of Burgess Point 7. Cromesett – From the beach in front of #4 Seahorse Lane southeasterly to the dock located at the northern end of Nobska Point 8. Portions of Sunset Cove rainfall area as identified on the shellfish status map. Areas open Thursday, Friday & Saturday 1. Management area #3 – Long Beach. All areas approved by the Board of Selectmen will be identifiable by the shellfish status maps located at the multi-service building near the Harbormaster's office, Tempest Knob Boat Ramp and the Onset Pier Harbormaster's seasonal office. Selectman Whiteside seconded.

- f. 09-01 Wareham Traffic Policies to include the Chapters Attorney Bowen to look at the policy to see what sections are relevant to the Board of Selectmen and which should be handed over to the road commissioners for them to adopt.
- Ghairman Teitelbaum said that this letter is a guidance letter by the accounting firm to provide guidance to the Board of Selectmen to identify issues in accounting. He said that this is a draft document that is prepared for the Board of Selectmen and he would like to propose a policy to discuss the receipt and handling of the document and when it should be released as a completed document. The consensus of the board was to have Chairman Teitelbaum draft a policy for the board to discuss at next weeks meeting.
  - h. Discussion and vote on rescission of Board's policy Special Municipal Employee Status

Chairman Teitelbaum said that he doesn't feel that this policy is helpful in getting volunteers and feels the policy was much too broad. He would like to rescind the policy. Selectman Tropeano said that they should not hold everyone else accountable because of one person. He would like to restore the special municipal employee status as we can accept it from State law. Selectman Whiteside seconded for discussion. Attorney Bowen said by rescinding the policy it doesn't automatically make everyone a Special Municipal Employee, you are just saying that you are willing to consider it on a case-by-case basis. Selectman Whiteside said that you do business by trusting people and supports the motion. Selectman Slavin said that it's a shame not being able to have qualified people on a board with this policy.

## 9. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan asked the board to sign the change in health care splits with the town employees. He said the projections with this split would be a savings of \$4 million dollars.

The Makepeace Neighborhood Fund has awarded a grant to the Harbormaster's Shellfish Department in the amount of \$8 for oyster restorations. Their proposal was among 24 that was submitted for funding. Mr. Sullivan wanted to thank Mr. Buckminster and his staff for working on the grant and also wanted to thank Makepeace.

Mr. Sullivan stated that <a href="https://www.mma.org">www.mma.org</a> has a community corner section and he noticed that on April 14<sup>th</sup> MEMA praised Wareham for it's emergency planning.

Mr. Sullivan spoke about the depreciation and the enterprise fund. He spoke that we don't budget for depreciation however they can list it in the audited statements.

Selectman Whiteside asked about the contractors for snow removal. Mr. Sullivan stated that they do have a process in place that they make sure all taxes are paid and they also make sure that they have insurance. Some discussion ensued about the plowing of roads.

Selectman Slavin asked if Mr. Sullivan could check with Municipal Maintenance on the inspection of parker Mill Dam.

### 10. LIAISON REPORTS

Selectman Whiteside attended the meeting for the School Superintendent search and stated that she was very pleased with the top three choices.

Selectman Slavin attended the SRPEDD Transportation meeting and said that the only project scheduled for Wareham is one bridge and the Rte 28 & 6 project has been put off until 2016. He said that they also spoke about bike paths. He suggested having the Bike Path Committee come before the board and ask how we can help them?

## 11. ADJOURNMENT

Selectman Slavin moved to adjourn. Selectman Tropeano seconded.
