Mr. Schrader spoke about the proposal for the usage based sewer fee and understands that the Town is concerned about the cash flow during the transition. They believe that this transition can be accomplished smoothly without the need for significant cash reserves.

The consensus of the board was to look into this further and come up with a policy that would allow remote access.
