Some of the items the board would like from Mr. Sullivan are to provide appropriate municipal support to all residents, continue to equitably plan expenditures between the school and municipal services side of the budget, work closely with the school to utilize/create positions that serve both sides of the government purchasing, human resources, payroll, etc., consolidate overlapping positions, continue to take advantage of, or create regionalization cost reductions, public safety, dispatching, municipal maintenance, maximize money savings opportunities, continue to monitor town spending and provide timely reports to the Selectmen, create/maintain a five year

moving forecast, cross train clerical staff, to best utilize personnel in high demand periods, prioritize municipal services, make hard decisions based on financial constraints and best practices, employee handbook.

- b. Presentation by Plymouth County Commissioners
  Present before the board: Sandra Wright
  Ms. Wright spoke about the services provided by the Plymouth County
  Commissioners. Some of the highlights she discussed were bills they have submitted
  such as bill #1286- rent reimbursements, bill # 2516 recalculate deeds & excise
  taxes allowing county to retain, bill # 2780 deeds recording fees, bill # 3363 State
  took over the Sheriff's department and left the retirees to pay, bill # 1829 to allow for
  a stabilization fund, bill# 3373 pension obligation bond. They are working on
  dredging programs along the coast. They manage the Mayflower Retirement Group,
- c. Vote whether to accept Police Chief's contract option year.

  Mr. Sullivan stated that Chief Stanley has asked that the town not exercise this option due to the fact that he is retiring. The process will begin shortly on hiring a new police chief and Chief Walsh will be the Interim Police Chief.
