After end of 1st sentence in paragraph 3 which ends with, clause 26 add: (this policy will include any changes made to MGL as concerns public information requests upon passage by the State of Massachusetts. 3. Eliminate 2nd sentence of last paragraph and replace with: This policy will set fee as follows: 30 cents per page copied; research time will be charged at a rate per hour to cover town's employee total hourly cost (including all fringe benefits and taxes) for the employee charged with performing research work. 4. Add new paragraph at end: Request for public information by Town Committee, Boards & Commissions appointed by Board of Selectmen shall submit said request with explanation to the Board of Selectmen showing how it falls info that Committee, Board or Commission's area of responsibility.

Those committee's Boards or Commissions shall submit to their "appointing authority". The Finance Committee thru rights provided by MGL shall be exempt.


