7. <u>SEWER BUSINESS</u>

- a. Funding source for contract 2.
- b. Sewer connection for 3 Tyler Avenue

Present before the board: Guy Campinha

Resident at 3 Tyler Avenue is looking for approval to connect to the sewer at 3 Tyler Avenue.

MOTION: Selectman Slavin moved to approve the connection with the attached conditions as presented (as attached). Selectman Holmes seconded.

VOTE: 5-0-0 (Unanimous)

- c. Sewer Easement, 3 Old Glen Charlie Road, Sewer connection
 Present before the board: Guy Campinha & Roy Christoferson
 Mr. Christoferson was before the board looking for the board to grant a sewer
 easement. Mr. Christoferson was looking to tie into the sewer since his septic system
 is failed. The board had some additional questions that they would like answers to
 before granting the easement and has asked that this be placed on the next agenda.
- d. Any other sewer business Mr. Sullivan stated that the DOR came back for a second day and met with himself and Selectman Whiteside. The DOR also interviewed the staff at the WPCF and should have a report back to the Town in about 6 weeks.

8. TOWN BUSINESS

a. Discussion on guidance to Town Administrator for the next year. Selectman Tropeano would like to have Town Administrator reports to bring the board up to date on information that the Town Administrator has dealt with and would like this prior to the meeting so he could review it ahead of time.

Selectman Holmes stated that people who have events planned should be aware that the parking lots are going to be used for revenue and they can't use them for the events. He also said that he was impressed by the Superintendent Kimberly Shaver-Hood and he read a comment from her that the School would have difficulties contributing to the \$500,000 reduction because they overspent the budget by \$330,000 last year. Mr. Sullivan stated that when the FY13 expenditure report showed a \$330,000 surplus the staff purchased items and after closing the books and looking at the Vadar report it showed where the money was.

b. Votes whether to place proposed articles on Town Meeting Warrant.

MOTION: Selectman Tropeano moved that 1-8 CPC articles with the exception of #6 contained in the packet on the warrant for the annual town meeting. Selectman Holmes seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Tropeano moved to put the TDR article on the Town Meeting Warrant. Selectman Whiteside seconded.

VOTE: 5-0-0 (Unanimous)

Charter Change - To change the submission dates of the Town Administrator's and School Committee's budgets for annual Town Meeting.

MOTION: Selectman Tropeano moved to place the Charter Change article on the warrant. Selectman Whiteside seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Whiteside moved to place the petition article for the acceptance of Cranberry Lane on the warrant. Selectman Holmes seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Whiteside moved that the article for the acceptance of Lynne Road be placed on the warrant. Selectman Tropeano seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Whiteside moved to place the article from the Harbormaster to raise and appropriate or transfer \$78,546.00 from the Harbor Service Permit reserved for appropriations account to the General Fund for Personnel. Selectman Holmes seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Whiteside moved to add to the warrant the article from the Harbormaster for Chapter 44, Section 53E 1/2. Selectman Holmes second.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Whiteside moved to place on the Regular town meeting warrant articles 1, 2 & 4 and on the Special town meeting articles 3, 5, 7 & 8. Selectman Holmes seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Tropeano moved to place on the warrant the Animal Control, Division VIII, Article II, Section 3 – Beach/Marsh article. Selectman Holmes seconded.

VOTE: 5-0-0 (Unanimous)

c. Any other town business not reasonably anticipated 48 hours prior to the posting of this meeting.

9. TOWN ADMINISTRTOR'S REPORT

Mr. Sullivan thanked Chief McDuffy & Captain Dykas for working with the Town and Municipal Maintenance in receiving a permit to turn off the sprinkler system at Tremont Nail. It would be very costly to replace that sprinkler system.

Mr. Sullivan met with the Superintendent as well as the Business Manager and they went over the plans to reduce, which includes freezing of planned purchases and reduction of seven staff members. This would now fulfill the \$500,000 reduction goal.

Vision has been awarded the tri-annual evaluation contract. They were the lowest bidder. Mr. Sullivan will be going before the Finance Committee to take \$22,000 out of the reserve to fund this.

10. LIAISON REPORTS

Selectman Slavin stated that the Onset Fire & Water met last week and voted to participate in the project with the town in ways to come up with synergies.

Selectman Slavin spoke about the interns starting from Bridgewater State University and UMASS.

Selectman Slavin touched upon the planning of the Oyster Festival by Wareham Village Association.
