Selectman Slavin stated that in the past they have required that something be put up that won't allow anyone to pass alcohol over the fence as well as having someone posted at the outdoor entrances. The board asked if anyone wanted to speak on behalf of the applicant — no one wished to speak sothe board voted to close the hearing.

The board received an email from The Town Clerk that she has received an acceptable resignation.

8. TOWN BUSINESS

a. Discussion on guidance to Town Administrator for the next year. Nothing was discussed.

b. Annual appointment of Town Counsel
The board expressed their satisfaction with having Attorney Bowen as Town Counsel
and stated that he was doing a good job.

MOTION: Selectman Whiteside moved to reappoint Richard Bowen, Esq. a term for one year for Town Counsel. Selectman Slavin seconded.

Attorney Bowen thanked the board for their vote of confidence

c. Discussion re: Vote whether to continue the Senior Work-off program.

MOTION: Selectman Whiteside moved to continue the senior work off program. Selectman Slavin seconded for discussion and stated that it should run smooth this year and it will be on the lottery system and will be fair.

d. Any other Town business not reasonably anticipated 48 hours prior to the posting of this meeting.

9. TOWN ADMINISTRTOR'S REPORT

Mr. Sullivan spoke about Workers Compensation insurance and stated that the school has high frequencies of Workers Comp claims which are mostly from the Teachers who work with the special needs students. They are planning on bringing someone in to provide some training on how to handle certain situations.

Mr. Sullivan attended Chapter 70 training last week in which they went over how the town receives state aid for education.

Parking Kiosks bids have been received and they in the process of going through them now.

A meeting will be held the 2nd week of April regarding parking.

Right now we have a \$274,000 deficit in the snow and ice budget. Mr. Sullivan stated that they did budget \$192,000 however, this year they have spent \$466,000. Some other budget items discussed was the transportation of homeless children he stated that the state provides \$100,000 and last year they expended \$160,000. The Veterans benefits are reimbursed 75% of what was paid the previous year. The Accountant salary line has increased so they could hire an Assistant Town Accountant. He has not budgeted for a Personnel Director; The Town Planner position has been budgeted. The FY15 budget does include leasing Police vehicles; Harbormaster's budget also has an increase for Personnel and that money does come from the Harbor Service permits in the amount of \$78, 546. The Municipal Maintenance is losing an employee. The Council on Aging is not legally mandated and it's currently not making any money and unfortunately it's one of the items that the town can lose. The assessments went up by 57% due to children going to other schools such as charter schools.

10. LIAISON REPORTS

Selectman Holmes stated that he should have a report together on the gas pumps before the board soon.

Selectman Slavin stated that SRPEDD has notified the Bike Path Committee that the Town of Marion should have their Bike Path finished in 1-2 years.

The Planning board will be holding three hearings on articles for town meeting on March 24th.

The Board of Selectmen will hold a meeting on the Charter articles on March 25th.

The Finance Committee is working on a budget presentation for town meeting.

The Plymouth 400 Celebration is planning an event that to celebrate Plymouth's 400th birthday in 2020, the cost is estimated at \$50 million for this event.

A sewer workshop will be held on March 15th at 10am in the Auditorium.
