He went on to say that the financial team isn't sitting on the sideline and they are reacting to resolve any issues.

b. Request for use of Town Property by the Onset Cape Verdean Festival Association, c/o Michael Roderick for their annual Cape Verdean Festival on August 9, 2014 from 7am-6pm (rain date August 10, 2014).

Mr. Roderick was asking for the use of Hynes Field & Lopes Field for parking at the Cape Verdean Festival. Mr. Sullivan had met previously with Mr. Roderick and felt that it would be fair for him to give the town \$1000 for the use of the fields for that day and keep the rest of the money. Some discussion ensued on whether or not to charge.

MOTION: Selectman Tropeano moved to approve the request by the Cape Verdean Festival Association for the use of the Onset Bandshell and Bluffs, and to close off a portion of Union Avenue, Waban Avenue, Centennial Ave as well as the use of Hynes, Lopes & Hammond School fields for their Annual Cape Verdean Festival on August 9, 2014 from 7am-6pm. Selectman Teitelbaum seconded.

c. Request for the use of Town property by Onset Bay Association, c/o Eleanor Martin for the Chalk-Full-O-Fun Street Painting Festival on Saturday, August 16, 2014 from 9am-6pm.

MOTION: Selectman Tropeano moved to approve the application for the Chalk-Full-O-Fun Painting Festival on August 16, 2014 from 9am-6pm for the use of the Onset Bandshell, Bluffs and to close off a portion of Union Avenue. Selectman Holmes seconded.

6. TOWN BUSINESS

a. Advise to Town Administrator
Selectman Teitelbaum stated keep up the good work as well as Selectman Whiteside.
Selectman Holmes urged him to push for parking. He also told him to keep up the good work.

b. Discussion re: audit/management letter from Powers & Sullivan

c. Parking study and implementation in Onset.

Present before the board: Garry Buckminster

The board discussed the parking plan for Onset. The cost for residential parking would be \$30 per vehicle. Part of this program includes visitor passes for free for a 24 hour period. Also discussed were how much the fines would be for someone who would park without a permit. Selectman Tropeano feels that the tickets should be steep not just \$30 and perhaps even towing the vehicle. Selectman Whiteside stated that she took a ride with Mr. Buckminster and that virtually most of the homes have curb cuts. Selectman Teitelbaum would like to send a letter to the Road Commissions asking them to increase the fines to \$100 this way the burden would shift onto the violators and offer free stickers to the residents.

MOTION: Selectman Tropeano moved to adopt the parking program as follows: Residential stickers at no charge, visitors will be charged a fee based on the program and non-reisents will pay a fee according to the program and that tow signs be posted

so that the town can use the money from the towing to help pay for this program. Selectman Whiteside seconded – Chairman Slavin asked Attorney Bowen if this was legal and he stated that according to the Charter section 39B the Board of Selectmen assigned these regulatory duties to the road commissioners and that the motion should read that the board recommends that the road commissioners adopt....Selectman Tropeano then moved to add that verbiage and Selectman Teitelbaum seconded. Selectman Holmes asked if it would be the Road Commissioners who would approve this plan? Attorney Bowen stated that yes, a proposal would be sent to the Road Commissioners for this parking plan. Mr. Sullivan said that on Highland Avenue if you can park on both sides then angle parking will not be added, on the right side of the Hammond School area we will do a blue line and on the left side it will be green. Selectman Tropeano stated to add that to the motion. Selectman Teitelbaum added to authorize the Chairman to send a letter to the Road Commissions to endorse this plan.
