Ms. Connaughton stated that the CEDA board has some items to discuss however; felt that it would be best dealt with during an executive session. Ms. Connaughton stated that the 195 Information Center is currently getting renovated to repair some leaks in the roof. The CEDA board did approve the Discover Wareham brochure. Mr. Pina stated that they have 45% of the funds left to expend on the FY13 grant. They have served over 3000 people with public service efforts. He is also an official member of the Greater New Bedford Workforce Board.

**MOTION:** Selectman Whiteside moved to adopt the instructions for special events permitting adding the following pages submitted by Selectman Teitelbaum and put in the fee section a fee of \$50 for the parent applicant and \$10 for each vendor or amusement operator that is coming under that permit effective immediately. Selectman Teitelbaum seconded for discussion to amend the motion to read \$25 for each vendor.

## 8. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan went over the FY14 Year End Budget Transfers (as attached).

Selectman Tropeano moved to approve the FY14 Year End Budget Transfers. Selectman Whiteside seconded.

Mr. Sullivan thanked Mr. Campinha and one of his employees at the WPCF for their work after one of the pump station was struck by lightning which caused a power surge at the plant. He stated that the employee was able to get the plant up and running.

So far the Parking Kiosks have generated \$40,300.75.

#### 9. **LIAISON REPORTS**

Selectman Whiteside stated that she has been working with Chairman Slavin on condensing of boards and commissions and the guidelines with improving what boards and commissions can do. She asked Attorney Bowen to share the guidelines; he stated that the Selectman shall hold regular meetings at least twice per month and all other boards shall meet at least once a month. Minutes of all open sessions shall be created and approved in a timely manner. The minutes of any open session, if they exist and whether approved or in draft form, shall be made available upon request by any person within 10 days.

Selectman Tropeano stated that he met with Mr. Campinha and talked about some issues such as the grease ordinance as well as Swifts' beach coming up soon. Also discussed were EDU vs Water rates and he said that he is inclined to go with the water in water out and it's time for the Water Pollution Control Facility to come up with a plan and advise what guidance they need. Other issues raised were the way some betterment was charged and the board needs to talk about that. He has another meeting at 4pm with Guy tomorrow.

Chairman Slavin stated that the Planning Board met last night and the Dollar General Store was approved with some conditions and expects ground breaking within the next month. The Route 28 and Tobey Road property site plan was approved as well with conditions. Next Monday Bay Pointe will be attending the Planning Board meeting to present the preliminary site review. The launch shuttle is also available for residents on the other side of Burgess Point.



#### POLICY STATEMENT

#### **USE OF TOWN PROPERTY**

It is the policy of the Board of Selectmen that no commercial activity shall be permitted to take place on any Town-owned or controlled property, including but not limited to beaches, parks, forests, public ways, parking lots, conservation and recreation areas, fields and grounds, playgrounds and cemeteries and/or beaches, without a permit from the Board of Selectmen. Commercial activity includes offering food, beverage or other goods and services for sale. Permit conditions shall include insurance at a level specified by the Town, which names the Town as Additional Insured. All town property used for parking shall remain under town control and all revenue for parking reverts to the town.

It is also the policy of the Board of Selectmen that Town property shall not be utilized for exclusive private events without a permit from the Board of Selectmen. This policy extends to the use of Town buildings, parks, playing fields, bandstand and gazebo.

This policy shall take effect immediately.

### **POLICY STATEMENT**

### CHAPTER 61A, §14 NOTIFICATION

Upon receipt, all Chapter 61A, § 14 notifications shall be referred to the Town Planner, CEDA Director, Community Preservation Committee, the Open Space Committee and the Wareham Land Trust for recommendation to the Board of Selectmen. Said committee shall have thirty (30) days to provide the Board with their recommendations. If a committee fails to respond within the thirty days, it shall be assumed the committee has no recommendations regarding the property in question.

This policy shall take effect immediately.
