1. CALL MEETING TO ORDER BY CHAIRMAN

3. ANNOUNCEMENTS

a. Discussion Wareham Housing Authority Sewer bill.

The Wareham Housing Authority was stating that the Town needs to look into
changing the way the sewer is billed. They stated that the water bill for the authority
is \$14,000 and the sewer bill is \$63,000 due to being charged and EDU for each
apartment. Mr. Powilatis also asked for the board to consider them utilizing the
services of the WPCF to provide service to the pump station at Redwood. Mr.
Campinha stated that they feel they could provide this service and would like
permission to pursue it and bring the cost back to the board. They also brought up

an issue with getting some late fees adjusted. Chairman Slavin stated that a formal request would need to go to the Treasurer requesting an adjustment.
