1. CALL MEETING TO ORDER BY CHAIRMAN

2. ROLL CALL

3. ANNOUNCEMENTS

Chairman Slavin held a moment of Silence in memory of Paul Fleugal who passed away on Saturday. Mr. Sullivan read a statement from Chief Walsh and Selectman Tropeano also stated that he will be missed.

The Flu Clinic scheduled for October 2nd has been cancelled and Flu Shots will be given out every Thursday from 9am-10:30am in the Multi Service Center, Room 106.

Selectman Whiteside thanked the musicians who raised \$500 for Damien's Pantry.

The Buzzards Bay Coalition and Wareham Land Trust will be holding three events the first event will be on October 10th from 5-6pm "Muddy in the Marsh" at Lyman Reserve, October 17th from 5-6pm "Make Your Own Fishing Pole" at Horseshow Mill and October 24th from 5-6pm "Orienteering/Scavenger Hunt" at Tweedy & Barnes.

Selectman Whiteside wanted to remind the residents that we do have a leash law.

Selectman Holmes said that he was happy to see that businesses and residents are continuing to clean up their properties.

Chairman Slavin stated that he has received word from Senator Pacheco's office that the House Bill for additional liquor licenses has been placed in "orders of the day" and they are in the process of vetting the bill.

Coffee Hour this Thursday will be held in the Community Room at the Redwood Village at 9am — this week's guest will be Mel Lazarus.

Chairman Slavin stated that the Building department has been receiving calls regarding the Glen Cove Hotel in Onset; he said that they did look into this and the elevator shaft is ADA compliant and was built within the legal boundary.

The Town is still looking for citizens to pick an area of town to be responsible for cleaning up the litter.
