CALL MEETING TO ORDER BY CHAIRMAN 1.

The Beach & Toursim Committee Is getting an intern from the High School to assist with the Destination Wareham website.

Selectman Holmes attended his first Kiwanis meeting and said that he was impressed how they encourage the kids to be leaders.

The Cranberry Harvest Festival will take place at AD Makepeace on October 11^{th} & 12th.

Selectman Holmes thanked everyone who made a donation in memory of Melissa Drake.

Selectman Tropeano helped out at the Oakdale Playground, he said that everyone had fun and they had a lot of people helping.

a. CEDA update

Present before the board: Jean Connaughton and Sal Pina Ms. Connaughton provided the dates for the Notice of Request for Proposal for the FY15 Community Development Block Grant. Mr. Pina spoke about the cost estimate for the Everett School. Selectman Holmes said asked what exactly CEDA has planned to save the parking lot or the Bay Pointe property.

b. Continued discussion and vote on citizens' petition article Chairman Slavin recommended that the board move no action on article #34 -Charles Rowley just went out to inspect the road today and the Planning Board should have his report by next week.

TOWN ADMINISTRATOR'S REPORT 8.

The DOR will be at the Town Hall on October 20th to help set the free cash and retained earnings.

Mr. Sullivan attended the 2nd meeting with the COA, he said that the group has lots of energy and they are looking to work hard and he thanked them.

Mr. Sullivan thanked Detective DaSilva for alerting the Board of Health of a hole he noticed in a driveway while serving a warrant, it turns out that the hole was due to an open sewer pipe being exposed. The Board of Health was called and the owner of the property will be fixing the pipe.

An examination date has been scheduled for the Chief of Police Assessment which will take place on November 6th. Interested candidates need to apply in writing to the Town Administrator by October 30th at 3pm.

The reconstruction of 12th street in Onset will begin on Tuesday, November 2nd and should be completed by December 4th.

Selectman Teitelbaum has been meeting on Thursdays with Town Counsel and the Town Moderator to go over the boards sponsored Town meeting warrant articles.

Selectman Tropeano spoke about the Swifts beach sewer project and explained that this would be for maintenance because it's been many years since that area was sewered.

Chairman Slavin was at SPREDD and they were discussing looking local towns to get GATRA involved in getting people to their medical appointments.

Chairman Slavin wanted to make mention that the Town has no say with the Water and Fire Districts.
