Mr. Decker was before the board seeking approval of a Conservation Restriction on the Weweantic Ridge Property.

**MOTION:** Selectman Teitelbaum moved to approve the Conservation Restriction, subject that the provision that the phrase (or equivalent) be inserted "such permission shall not be unreasonably withheld" in each place where the Buzzards Bay Coalition may give the Town an approval as relates to the Conservation document that was presented for the East Side of Blackmore Pond Road, Book 41678 at Page 311 Plymouth County Registry of Deeds. Selectman Whiteside seconded.

VOTE: 5-0-0 (Unanimous)

**MOTION:** Selectman Tropeano moved to pledge the property that is under agreement with the Buzzards Bay Coalition on book 41678 at page 311 Plymouth County Registry of Deeds to the Department of Interior Fisheries and Wildlife Service Division of Bird Habitat Conservation 5275 Leesburg Pike, Falls Church VA. Selectman Whiteside seconded.

e. Vote to approve the ABCC Seasonal Renewal Certification for 2015

**MOTION:** Selectman Tropeano moved to certify the seasonal renewal certification for 2015 as follows: Licenesees who failed to renew for 2015 - 0 – Licensees disapproved by the City/Town for 2015 - 0. Selectman Whiteside seconded.

Selectman Holmes brought up the issue of people selling used goods without a license and wanted Attorney Bowen to distinguish what the difference is between a Junk Shop, Junk Collector and a Pawn Broker. Attorney Bowen said that if you sell goods in a shop then you would need a junk dealers license, if you collect junk in a pickup truck and don't sell it then it's a junk collector and if you are a pawnbroker you would be receiving goods and loaning them money then you are a pawn shop.

#### 10. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan stated that they have received many complaints about County Road. He said that they have been trying to patch it however, the patch didn't take. He said that they are going to be going out on the next sunny day.

### 11. LIAISON REPORTS

Selectman Teitelbaum attended the Cemetery Commissioners meeting in which they discussed the article on the Spring Town meeting warrant to acquire 2 acres located adjacent to the Agawam Cemetery.

Selectman Whiteside congratulated the Council on Aging for their activities and joining in with the Library Fundraiser. The Veterans Council has been very active.

Selectman Holmes spoke about a Junk Dealers business on Cranberry Highway and asked that the board hold a hearing on the violation of his license. He said that the board of health has been there and have taken photos of the junk around the building.

The board would like to hold a meeting with the duly elected Sewer Commissioners along with Tighe & Bond. They were looking to hopefully hold a meeting next Wednesday evening.

Chairman Slavin would like to write a letter to Mass DOT concerning County Road as well as Marion Road. County Road is in desperate need of repair he would like a traffic study done to lower the speed limit from Cranberry Cottage down to the Shaw's Plaza as well as have some flashing lights near the crosswalk located near the Country Market.

**MOTION:** Selectman Teitelbaum moved to authorize the Chairman to write both letter. Selectman Whiteside seconded.

VOTE: 5-0-0 (Unanimous)

Chairman Slavin attended the Legislative breakfast in which four reps from the area were present, they discussed Governor Baker's budget.

Selectman Holmes stated that nobody has legal authority to tell them they can violate the town by-law.

Selectman Teitelbaum asked that the board endorse him to write a letter to the Governor to restore funding for Beach & Tourism.

**MOTION:** Selectman Tropeano moved to authorize Selectman Teitelbaum to write the letter. Selectman Teitelbaum seconded.

**MOTION:** Selectman Tropeano moved to also along with the School Committee write a letter to the Governor regarding funding. Selectman Teitelbaum seconded
