7. TOWN BUSINESS

a. Update liquor policy for release of license Selectman Slavin stated that the Director of Inspectional Services came up with 9 steps that should be taken prior to issuing a liquor license.

MOTION: Selectman Whiteside moved to approve the Policy to Secure License for Liquor and Common Victualler 1. Confirm zoning appropriateness 2. Apply to Board of Selectmen for license application. 3. Application is issued if applicant is qualified, but held. 4. Apply to inspectional services, fire department, water department, board of health and water pollution control facility for modifications to the unit. 5. Complete modifications and pass final inspections with all pertinent departments and obtain a Certificate of Occupancy for the premises (standard form in all modification projects). 6. Apply for change of use or occupancy. 7. Apply for a certificate of inspection (standard state certificate issued every year). 8. Request release of his license from the Board of Selectmen upon presentation of a certificate of inspection. 9. Establishment can now open. Selectman Slavin seconded.

b. Presentation on the Wareham Village Parking Study Present before the board: Lisa Jacobson from Nelson/Nygaard Consulting Associates and Sal Pina, CEDA Director.

Ms. Jacobson presented the board with a copy of the Wareham Village Parking Management Plan (on file at the Selectmen's Office). Ms. Jacobson stated that the study was done from the fire station to the bridge. The area has 1300 spaces, most off street and privately owned. Merchant's Way during the busiest time of day is about 50% full. She spoke about the redesign of Merchant's Way and by using Merchant's

Way as a second Main Street it would also encourage businesses to utilize their existing back entrances as second front doors.

- c. Discussion re: policy 08-10 This item was not discussed since all members of the board were not present.
- d. Discussion on possibility of banning sale of nips in Package Stores. Selectman Whiteside read an article "Thinking Out Loud In Sturbridge" (as attached) regarding the banning of nips. The board would need to present to Town Meeting a warrant article that would require a special act to ban or have a deposit on nips that are sold in Package Stores.
- e. Vote on Assistant Assessor position Mr. Sullivan stated that 15 applications were received, 7 were interviewed by the search committee which consisted of Matthew Underhill, Roxeanne Barboza and Jacqui Nichols. After all the interviews were completed they agreed that the best candidate is Steve Curry.

MOTION: Selectmen Slavin moved to appoint Steve Curry as the Assistant Assessor. Selectman Whiteside seconded.

Mr. Sullivan asked Ms. Priscilla Porter to speak about a raffle being held at the Library. Ms. Porter stated that Christine Heyworzy created a quilt that is being raffled off with the proceeds to benefit the Friends of the Free Library. Tickets are only \$5 each and may be purchased at the Library.

Mr. Sullivan stated that with the recent passing of Mary Scarsciotti, the ZBA will need to make sure that they don't have any lapse in any decisions. Mr. Sullivan did suggest that boards and committees hold their meetings in the Selectmen's meeting room so they can be taped live, not tape recorded.

The House Ways & Means Committee set the Cherry Sheet, the State aid received is \$42,008 however the tuition assessment will be \$42,730 which means a decrease of \$722.00

Selectman Whiteside stated that the Veteran's Council is in the process of making sure that all Veterans Graves in town are marked with the appropriate medallions along with American Flags.

have always held a "No Interference" position when it comes to folks making decisions that I would not have made myself. I feel bad, but their life, their decision.


Unless, of course, I was asked. Then, I give my very best advice, referrals if necessary, and support.

So, when I see a scenario that is becoming increasingly more dangerous, and out of control, I will speak up, and I see one getting worse now.


