c. Application for Pawn Broker's License by Gateway Gold & Pawn, Inc., 294 Main Street, Wareham.

Present before the board: Dominic Cammarano

Selectman Whiteside stated that she has gone through the paperwork and everything is in order. Selectman Teitelbaum stated that he would approve this permit however; he would like to see this business at another location next year and not on Main Street. Selectman Teitelbaum also stated that the Stale Law requires that the board inform anyone with a Pawnbroker's license that no Officer, Director or employee is allowed to be a convicted felon. Selectman Whiteside would like to notify the applicant that this license expires on December 31, 2015 and that she would like to add that no goods should be displayed outside.

MOTION: Selectman Whiteside moved to grant to Gateway Gold & Pawn Inc., d/b/a Gateway Gold & Pawn, 294 Main Street, Wareham, a Pawnbroker's License to expire December 31, 2015 unless sooner suspended or revoked under the law. The stipulation is that the signs will conform to the sign by-law and that no items will be for sale or resale or free in front or side of the building. Selectman Teitelbaum seconded.

The Harbormaster sent an email to the Board of Selectmen regarding the removal of Navigational markers in the Wareham River. Mr. Buckminster is in opposition of this proposal by the Coast Guard and asked the board to send a letter urging them not to remove the markers.

The Parking Kiosks program as of August 10, 2015 has brought in \$114,583.50. Last year the total was \$97,774.

Selectman Holmes asked about getting a list of the disbursements from the Community Events Committee.

Selectman Slavin stated the retirement event held this past Friday for Dana Mohler-Faria was a very nice event.

The Blues Festival was a well-run event and they did a great job cleaning up after the event. Selectman Slavin stated the only problem was that there wasn't' enough parking.

Selectman Slavin met with Michael MacMillan from the School Department to discuss the School busses.

Selectman Whiteside has been working on revising the forms for all permitting. She also asked Mr. Sullivan if he has any plans on digitalizing records.

Selectman Whiteside reminded boards and committees to submit their reports by the deadline of August 31st.

Selectman Whiteside stated that the Coast Sweep put on by the Commonwealth of Massachusetts is asking volunteers to pick a place and clean it up. They would like to
