We are trying to meet the goal of completing this by March 15<sup>th</sup> – a goal set by the bike path committee.


**Communications from Marion and Plymouth pathways** – the participants from the other towns were unable to attend.

**Input from other town departments / committees** – the bike path committee wishes to thank John Charbonneau and Dave Pichette for their work to compile the abutters list.


Meeting adjourned at 7:15.
