Michael Langford called the meeting to order at 6:10.

June meeting minutes were approved.

Sal Pina, CEDA Director, was invited to the meeting to discuss the proposed project on Merchants Way. Sal gave an update on the Streetscape project and the suggestion to make Main St one way and Merchants Way one-way also. He is working with GATRA to have Merchants Way multi-modal with trains and a pathway. There may be wetlands issues with a section of the pathway – WBPC will have to speak with Dave Pichette, Conservations Commission. Sal was asked if the WBPC can do a design study for the pathway on Merchants Way to coincide with the construction of the Streetscape project – he was in favor of this suggestion.

**Surveys on Town website** – results are on the bike path site, currently 96% favorable.

**Friends of the Pathway update** –the Friends group would like a joint meeting with the bike path committee; this will be scheduled in September. The purpose of the meeting is to give an update and to discuss how the Friends group can help.

**Publicity / Community Events**– Cranberry Festival is scheduled for October 6 & 7<sup>th</sup>.

**Project Needs Form** –waiting to determine if the inactive rail line will be revisited or to contact Adam Recchia to schedule a meeting with Rochester and Marion to discuss County Rd.


