Presentation by Chris Coile

Chris Coile a part-time resident of Wareham with extensive experience in real estate and fund raising for projects in Annapolis Royal, Maryland presented a proposal for to further the downtown revitalization. The proposal is attached for review is well done but would have one caveat. Mr. Coile requested that he be appointed Chair of a sub-committee with overall responsibility for the project.

After much discussion the chairman noted that CEDA could not participate in some of the proposed activities and unable to give him the authority over the grant process.

After further discussion, the board recommended that Mr. Coile meet with the Wareham Village Association to determine their buy in and that Chris Reilly attend the meeting so that both entities were aware of the responsibilities and commitment.
