3. Deeds approved were:



4. Mosquito Dam road was discussed due to heavy volumes of traffic traveling through the cemetery. Fears are that there maybe potential damage done to stones if the road becomes a "pass thru". The Commissioners will talk to Road Commissioners requesting access be denied as a pass thru as it is a town accepted road.
5. The location of a Cremation Park was discussed. The wooded area to left, far in the back at Agawam Cemetery could be incorporated in with the new area to be built. This will be a long term project.

6. Bring cemetery mapping designed by Churchill of the survey done in the Agawam Cemetery, which can be reviewed at the next meeting.. The town needs to open up another area of the cemetery for new graves and cremations.
