III. PRELIMINARY BUSINESS

A. Approve meeting minutes of April 16, 2014

MOTION: Ms. Slavin moved to approve the meeting minutes of April 16, 2014. Mr. Baptiste seconded.

VOTE: Unanimous (4-0-0)

IV. PUBLIC HEARINGS

A. RDA - Edward J. Pacewicz, c/o G.A.F. Engineering, Inc.

The public hearing notice was read into the record.

It was stated that this hearing will be continued.

MOTION: Mr. Baptiste moved to continue the public hearing for Edward J. Pacewicz to May 21, 2014. Mr. Carboni seconded.

B. NOI - Michael Connors, c/o G.A.F. Engineering, Inc.

The public hearing notice was read into the record.

Mr. Pichette described the project. The property is located at 13 Salt Creek Road, off Lydia's Island Road. The project involves the construction of a pier, ramp, & float system into Shell Point Bay & repairs to an existing seawall. A 124' pier, ramp, & float system would be constructed. 18 12' green heart piles would be installed by a floating barge for the structure. The floats would be 10x30' in size. They are showing a depth of 2.5' of water in the vicinity of the float at low tide. He questioned how much water the float draws, what size boat & draft is being proposed, & if an eel grass study was done for the dock location, & if so, when was this performed. He stated an eel grass study should be done between July 1st & November 15th. He also asked where the floats would be stored in the off season & the removal methodology. He stated comments have been received from DMF on the project indicating the site is w/in mapped shellfish habitat for American oyster, bay scallop, quahog, & soft shelled clam. DMF also states that the area is a shellfish relay area. DMF further states that habitat loss w/ piling installation may require mitigation at the State or Federal levels of permitting. Comments have not been received from the Harbormaster. He asked what the nature of the seawall repairs are. He noted a DEP file number has been assigned. He recommended a continuance of the hearing at this time for additional information.

Brief discussion ensued re: the project.

MOTION: Mr. Carboni moved to continue the public hearing for Michael Connors to May 21, 2014. Mr. Baptiste seconded.

C. NOI - Mark Hays, c/o G.A.F. Engineering, Inc. - SE76-2299

The public hearing notice was read into the record.

No-one was present for the public hearing. The Commission concurred to continue the public hearing.

MOTION: Mr. Baptiste moved to continue the public hearing for Mark Hays to May 21, 2014. Ms. Slavin seconded.

D. NOI – Wareham Fire District, c/o Kleinfelder

Present before the Commission: Michael Martin, Wareham Water Dept. Superintendent Mr. Monahan

NOTE: Mr. Baptiste & Mr. Connolly abstained from the discussion of this project.

The public hearing notice was read into the record.

Mr. Pichette described the project. A site inspection was made at Agawam Road in East Wareham. The project involves the installation of a water main & buried electric line to serve a new drinking water production well. This work will be done in the buffer zone to a bordering vegetated wetland & w/in a riverfront area of Maple Springs Brook. 4500 ft. of 8" water main is to be installed w/in existing gravel bog roads to connect the new production well to the existing water system mains. The installation of the new well was previously approved by the Commission under a separate OOC. There will be one culvert crossing involved. The main will be installed over the existing box culvert. In other areas, the work will be in the buffer zone to a bordering vegetated wetland. Trenches will be backfilled as the project progresses so that trenches are not open for extended periods of time. Haybales will be installed in areas adjacent to wetlands.

Also proposed, as part of the project, is a pump off test for the new well. This will require continuous pumping for 30 days at a rate of 700 gal./m. Water will be directed into a haybale containment area where the water would filter through & flow toward Glen Charlie Road. A DEP file number has not been received at this time. He recommended a continuance to await the receipt of a DEP file number.

Brief discussion ensued.

MOTION: Mr. Carboni moved to continue the public hearing for Wareham Fire District to May 21, 2014. Mr. Leggett seconded.

V. CONTINUED PUBLIC HEARINGS

Mr. Pichette described the project. A site inspection was made at 790 Main Street (or 13 Station Street). The project involves the construction of two additions to an existing commercial building w/ associated parking lot expansions & stormwater drainage structures in the buffer zone to bordering vegetated wetlands. The two proposed additions, 7,000 sq. ft. & 20,000 sq. ft. are both outside the buffer zone to the wetland. The proposed stormwater detention basins & outfalls, as well as portions of the proposed parking lots are w/in the buffer right up to the edge of the 50' no activity zone. The project is broken into two phases on the plan, but the Commission is reviewing the entire project under this NOI. The stormwater drainage systems are being reviewed by Charlie Rowley at this time, but that review has not yet been completed.

Mr. Pichette stated he has reviewed the wetland flags shown & feels that a few would need to be adjusted. He will be meeting w/ the wetland consultant to review the wetland flags. A DEP numbers has been received. He recommended a continuance for the stormwater review report & to evaluate the wetland flags.

Brief discussion ensued.

MOTION: Ms. Slavin moved to continue the public hearing for Smithers Viscient, LLC to May 21, 2014. Mr. Baptiste seconded.

VOTE: Unanimous (4-0-0)

D. NOI - Richard K. Edge, c/o G.A.F. Engineering, Inc. - SE76-2298

Present before the Commission: Paul Mattos, G.A.F. Engineering, Inc.

Mr. Pichette described the project. A site inspection was made at 26 Pinehurst Drive. The project involves the repair of an existing seawall along a coastal beach, salt marsh, & w/in a coastal flood zone. This filing is made in response to a violation that occurred at this tie when repairs to the wall were started before the Commission reviewed or approved the project. It is proposed to drive vinyl sheet piles in front of the existing stone wall & in front of the collapsed area as well. The access stairs will also be reconstructed as part of the project. Work will be done from the upland side of the property & the sheet piles will be driven w/ a vibratory hammer or mini-excavator. No machinery will be on the beach. Excess stone & rubble from the site will be removed

from the site. A DEP file number has been received. He recommends the granting of an OOC w/ standard conditions & the added condition that no machinery be placed on the beach.

Discussion ensued re: issuing of a fine. The Commission members concurred to issue a \$300.00 fine.

MOTION: A motion was made & seconded to issue a \$300.00 fine for Richard K. Edge.

MOTION: Mr. Baptiste moved to close the public hearing for Richard K. Edge. Ms. Slavin seconded.

E. NOI – James & Deborah Andrade, c/o Outback Engineering, Inc. – SE76-2297

Mr. Pichette described the project. A site inspection was made at 30 Salt Marsh Lane. The project involves the construction of additions, a deck, & stone steps in the buffer zone to a coastal bank & to Sunset Cove. A 10x15 ft. addition is proposed between the dwelling & the garage 13 ft. from the top of the coastal bank & a 10x21 ft. addition is proposed at another corner of the house 30 ft. from the top of the coastal bank. Also proposes is a 10x45 ft. deck w/ stone paver landing w/in 5 ft. of the top of the coastal bank. Silt fence is proposed between the work & the resource areas. Some of these proposed features are w/in the 30 ft. no activity zone. He recommends the plan be revised to reduce the proposed structures in the 30 ft. no activity zone. A DEP file number has been assigned. He recommends a continuance for a revised plan.

Discussion ensued.

MOTION: Mr. Baptiste moved to close the public hearing for James & Deborah Andrade. Ms. Slavin seconded.

Ms. Ezepik and Mr. Mulkern explained the reasoning for the placement of the stones on the beach which included trying to prevent vehicles from driving on the beach, and trying to prevent stormwater runoff from washing out the beach. They described problems with existing catch basins in Wychunas Ave. and how they are not functioning properly. This problem is causing washouts on Wychunas and the beach area.

Mr. Pichette stated that the placement of a stone wall on the beach is not something that was permitted by the Commission, nor is it a project that could be permitted, as it would not meet performance standards in the wetland laws.

The Commissions concensus was to require the piled stones on the beach to be removed down to the base stones. The base stones which are embedded in the sand, and have been there for years, would be allowed to remain in place. The beach association reps agreed to this and stated they would begin the process of removing the stones.

Mr. Pichette recommends removal of the stone to the bottom layer.
