It appears that a deck is proposed on the side of the dwelling. There is a question as to if this is planned. If so, this proposed work should be added to the plan. The work involves the installation of sono tubes for the structures. No grade changes are proposed. If no other work than the addition is proposed, then the Agent recommends the issuance of a Negative Determination #2 for the

project. If other work is proposed, then the Agent recommends that the plan be revised prior to closing the hearing. Brief discussion ensued.
