Mr. Pichette described the project. The property is located at 265 Barker Road, previously owned by A.D. Makepeace, Co. The project is being proposed as a limited project & involves the restoration of 75 acres of retired cranberry bogs into wetland & stream habitat. Also proposed is to improve the stream channel of Red Brook through the bog system, for the purpose of improving migratory fish passage. The project involves work w/in a BVW, land under a water body, inland bank, estimated habitat of rare & endangered species, & a migratory fish run. The stream channel will be improved by modifying the stream route w/in the bog system to be a more uniform channel w/ no obstructions. Plantings would be used along the edge of the stream channel to provide shading for the stream. Improvements may also be made to the fish ladders that exist at either end of the property. Work in the existing 75 acres of bog will involve the removal of the sand layer of the bogs & the plant material. Removed soils will be relocated back into the borrow pits around the bogs. The existing bogs would be reshaped & graded according to the submitted plans to create a variety of wetland habitats. A DEP file number has been issued stating that other State permitting may be needed. The MA Div. of Marine Fisheries has commented on the project & is requiring some time of year restrictions on the project. No silt

producing work between March 15- June 30. The project must provide unobstructed fish passage between March 15- June 30 & Sept. 1 - Nov. 15. The MA NHESP had no negative comments.
