# III. TOWN ADMINISTRATOR'S REPORT

#### A. State Resolution.

Mr. Andrews noted that a resolution passed by the Senate provides \$12,225,154.00 for Chapter 70 funds and \$1,552,495.00 to unrestricted general government aid. It remains to be seen what the conference committee's recommendation is. He stated he will continue to closely follow this.

## B. Accounting Support.

Discussion ensued re: the process for maintaining accounting support for Town operations in the absence of a Town Accountant. Discussion ensued re: the importance of reliable ongoing accounting support going forward. It was stated if necessary, the process to find a new Accountant could take up to six weeks & the pool of qualified personnel is not great.

#### C. DOR Letter.

Attorney Bowen discussed the letter received from DOR recommending the Town not spend pre-certified Free Cash until the of \$919,000 un-reconciled funds is resolved by the auditors. This process is expected to be completed in the next several weeks, well ahead of the Town Meeting in May.

#### D. Warrant Articles.

Mr. Andrews stated that based on the unsettled financial situation, all fiscal articles on the 2011 Spring Annual & Special Town Meeting Warrants will be postponed until the May 23, 2011 Town Meeting date.

#### E. Warrant Article Motions.

Motions for non-financial articles for the Annual & Special Town Meeting Warrants were distributed & discussed individually by Attorney Bowen. It was noted that some articles to be considered at the April 25, 2011 Town Meeting Warrant may be withdrawn in the meantime.
