I. CALL MEETING TO ORDER

The meeting was called to order at 6:31 P.M.

III. CITIZENS PARTICIPATION

No-one came forward for Citizens Participation.

IV. TOWN ADMINISTRATOR'S REPORT

There was no Town Administrator's Report.

V. FINANCE COMMITTEE MATTERS

- A. Review & vote on article for the 2015 Annual Spring Town Meeting warrant.
 - 1. Article 20 Petition Adoption of MGL Chapter 148.26H

Present before the FinCom: Chief Robert McDuffy

Assistant Chief Patrick Haskell

Chief McDuffy gave an overview of the intent of this article. He discussed fire department statute Chapter 148.26H. He stated this statute would enable the Fire Dept. & the Building Inspector to make sure any boarding houses &/or lodging houses are safe. He stated he has spoken to the Onset Fire Chief & he is on board w/ moving forward w/ this statute as well.

Chief McDuffy noted that there are currently no boarding houses/lodging houses in either Wareham or Onset districts presently. He discussed the definition of a boarding house & a lodging house. He reiterated that as he understands, there are currently no licensed

boarding/lodging houses in Town presently. He noted that one illegal boarding/lodging house was found in Town last year.

Discussion ensued re: costs of putting in these types of fire suppression systems. Chief McDuffy stated each boarding/lodging house would be reviewed on a case by case basis.

Ms. Cottuli asked what happens if someone renovates a building into a bed & breakfast. Chief McDuffy stated it would depend on how many rooms there are & how the building falls into the building code. The whole picture would be looked at.

NOTE: Mr. Cammarano arrived at this time.

Chief McDuffy stated if the building exceeds the definition in the statute, it would need to comply w/ the regulation. He stated the Building Inspector would have a large role in reviewing the scope of a building.

Mr. Worthen stated that there will be many questions at Town Meeting that will need to be answered. Ms. Cottuli feels there is a lack of information. Chief McDuffy noted the Building Inspector needs to answer some of these questions re: building codes.

Chief McDuffy noted that hotels/motels fall under an exemption.

Ms. Cottuli stated she understands the safety issue, but there is also an economic factor as well for people living in these buildings & for the building owners. Chief McDuffy stated safety trumps everything, even money.

Mr. Cammarano spoke re: a Board of Health regulation preventing non-related amounts of people in an apartment house.

Chief McDuffy explained this is basically a sprinkler law. He noted that this article will also be placed on the Fire District's Annual Warrant.

Mr. Heard discussed the Board of Health regulations & inspections in place presently. He feels the wording of the article is vague re: the intent of the article. Chief McDuffy stated this is a stature. He discussed a scenario of how the process may play out. (Someone goes to the Building Inspector & tries to pull a permit. The Building Inspector would then inform the Fire Dept. on the intent for a boarding/lodging house). He stated this would also include a change of use (occupancy).

Chief McDuffy stated this statute has been enacted in 105 communities in MA.

MOTION: Mr. Cammarano moved Favorable Action on Article 20 of the 2015 Annual Town Meeting Warrant. Ms. Jordan seconded.

Several members expressed an interest re: the impact this article would have in Onset.

VOTE: (4-4-0) Mr. Worthen, Mr. Bailey, Mr. Heard, & Mr. Langan opposed

Ms. Cottuli stated she will reach out to the Building Inspector & the Onset Fire Chief for their input. She stated there is still time to do this prior to Town Meeting.

MOTION: Mr. Cammarano moved to reconsider the FinCom's vote on Article 20 of the 2015 Annual Town Meeting Warrant. Mr. Langan seconded.

VOTE: Unanimous (8-0-0)

MOTION: Mr. Cammarano moved to rescind the FinCom's vote on Article 20 of the 2015 Annual Town Meeting Warrant. Mr. Heard seconded.

VOTE: Unanimous (8-0-0)

B. Review 2015 Special Town Meeting Warrant.

The FinCom proceeded to review & discuss the articles included in the 2015 Special Town Meeting Warrant. (Attached as reference).

Article 11 - Community Preservation: Oakdale Playground

MOTION: Mr. Heard moved Favorable Action on Article 11 of the 2015 Special Town Meeting Warrant. Mr. Langan seconded.

VOTE: (7-0-1) Ms. Fontes abstained

NOTE: Ms. Cottuli asked Mr. Cammarano if Upper Cape representatives will be present at the FinCom's 3/25/15 meeting to discuss Article 8 of the 2015 Annual Town Meeting Warrant. Mr. Cammarano stated they would be present. Ms. Cottuli stated the BOS are invited to attend this meeting as well.

Ms. Cottuli stated Ms. Bronk will be meeting w/ the School Committee & the Town Administrator for updates on the budget.

She stated it is for an engineering study & will go out to bid for capital. It will also go through the SBA process which has already been started. Discussion ensued re: borrowing for this.

Mr. Cammarano stated the budget for Upper Cape includes a chart that is very interesting. He stated for Wareham to send a student to Upper Cape, it costs approx. \$11,000. A student going to Wareham High School costs \$14,000. He finds this variance in numbers very telling. He stated in other towns, it costs the schools more to send students to Upper Cape vs. their own school system. Brief discussion ensued.
