Minutes, 12/12/12: George Barrett moved to approve. Miller asked to amend to include under playground evaluation other entities, "like the Board of Selectmen or Open Space Committee". Barrett approved amended Minutes, Donald Hall seconded. Vote 6-0-0.

Financial Report: Sandy Slavin explained Article 19 as simply a different interpretation of language by DOR: *transferring funds* had been interpreted as *raising funds*.

Other Updates:

 Digitizing Town Records – volunteers needed to refile drawers of cards in Assessor's Office before project can continue. Town Clerk's Office is up to date. All information will be available on CDs. CPC cannot pay for copies or sell copies. Dunham recommended a filing aid through tryneat.com.

- Wareham Land Trust Dunham investigating Dartmouth Land Trust's cost of holding conservation restrictions
- Tremont Nail Miller asked again when Brian Pfeiffer from Preservation MASS will be meeting in Wareham re. holding the historic preservation restriction. Sal Pina of CEDA is looking at Tremont Nail and will present more possible uses at Feb. 5th BoS meeting.
- Depot Crossing Affordable Housing Deed awaiting information from Kathleen O'Donnell.
- Town Hall Roof no current information.

 Miller noted that as yet there are no holders for the preservation restrictions for Town Hall, Old Town Offices, Oak Grove or the American Legion.
- Wareham Historical Society RFP ready to be advertised. Miller will contact Eric Dray regarding revising language for insurance of historic properties.
- Old Town Offices one estimate to date. Dunham will contact Mark Gifford re. RFP.
