# Request from Cafeteria Managers to Increase School Lunch Prices

Dr. Rabinovitch presented a certificate and pin to Mary Klueber, Cafeteria Manager at Wareham Middle School for her 20 years of service. Mrs. Klueber was not able to attend the last meeting.

Dr. Rabinovitch stated that meal prices have not changed since 2006. The cafeteria department operates on its own funds.

## West Wareham Academy

Mrs. Miranda described West Wareham Academy as a therapeutic day school which has been in operation for 2 years. She reviewed the school population, attendance and discipline, staffing, student performance data, and parent and community involvement. This year a school council was formed. She reviewed the extra curricular activities, professional development, and parent, student, and staff survey results and summarized the progress on the goals for 2010-11: student achievement, technology, community. The goals for 2011-2012 are Improvement of Student Achievement, Expand Community Involvement, and Integration of Technology.

Questions, comments and suggestions on some goals were given by the committee members. Mr. Swett asked for information on whether any of the students applied to vocational schools and the response.

# Reconsider Vote on School Choice for 2011-2012

Dr. Rabinovitch reported that the Department of Elementary & Secondary Education alerted him to a problem of an equity issue with the vote taken on school choice limiting the number of children with special needs attending the Cooperative School. An audit from another office in the Department of Elementary & Secondary Education said we should not go over a certain % of students in sped because the school is a regular education program.

Dr. Rabinovitch recommended the Wareham Public Schools continue as a School Choice district for the 2011-12 school year and accept students in grades Kindergarten through Grade 12 depending on class size and that no students will be accepted to the West Wareham Academy.

Dr. Sylvia moved to reconsider the vote taken on April 6, 2011 relative to school choice, seconded by Mrs. Veugen.

Mr. Swett moved the recommendation of the Superintendent, seconded by Ms. Gillette.

### **Acceptance of Gifts**

Dr. Rabinovitch recommended acceptance of 100 15" or 17" flat screen monitors from Boston HealthCare System valued at \$36,956 for the school district.

Ms. Gillette moved the recommendation of the Superintendent, seconded by Mr. Swett.

requested that the Superintendent ask the Town Administrator to keep the Ad Hoc Committee leading towards October Town Meeting with a capital plan and the FY'13 budget process.
