Budget Policy

- Dr. Rabinovitch explained the major details of the budget policy draft: delineates limiting changes to budget by superintendent without school committee approval. Includes definition of major accounts and sub accounts within each major account. Superintendent's authority to transfer limited to less than \$5,000 per major account and can only authorize changes up to \$5,000 among sub accounts within major categorical accounts. All other transfers would need School Committee approval.
- Dr. Sylvia suggested grammatical and verbiage edits. The full committee discussed each edit, reviewing the policy line by line.
- Discussion of budget philosophy versus policy of funding to comply with state educational funding requirements. Sentence added to state the "budget philosophy of Wareham School Committee is to fund at a level to achieve educational excellence." Exact changes made to policy draft.
- Discussion was detailed and came to a consensus.
- Motion by Mr. Flaherty, seconded by Ms. Freitas. Unanimous approval.

Senior Privileges

- Ms. DeBonise presented edits to the policy after a discussion with Principal Palladino
- Change to reflect Dean structure for Senior privileges
- Added statement that the school committee needs to approve senior privileges annually.
- Question of timeline for school committee approval.
