~The three articles for the Special Town Meeting were reviewed, a few changes made. We are just waiting for final numbers so they can be turned into the Selectmen for consideration.

~NRG, the new owners of the solar array on the landfill want to set up an onsite meeting. The best day for us is November 9, 2017 at noon. Mrs. Carney will post a public meeting to be held at the landfill. They also want the Board to approve the proposed new location of the guy wire. Mrs. Carney will send plan to Anchor Engineering for review and approval.

### Bills, Payroll, and Minutes

#### Other

~Hauler Regulation and Well Regulation discussion tabled to an undetermined future date.

~Planning Board applications reviewed; Special Permit #279, zoning permit #278 and Site plan #44 reviewed. No regulatory issues were noted.

~Mrs. Carney reported on behalf of Mrs. Toon that the inspection of the sandpit on Brimfield Rd, owned by John Fijol, on September 21, 2017 revealed no evidence of a reportable release of hazardous material. The only evidence remaining of the junked automobiles were two small surface stains, presumed to be oil, measuring approximately 4" each. She noted the cars had been removed prior to the inspection. She also noted several scattered barrels and confirmed they were all empty and showed no signs of prior leaking. Mrs. Toon took photographs which were shared with the Board.

~Mrs. Carney needs a list of available dates from all members by October 2, 2017 to provide to PHEP so a practice dispensing site can be set up at North Brookfield High. All member need to be in attendance for the state required drill. The setup is required to take place by the end of 2017.

~Mrs. Carney announced that we were awarded the RPD recycling grant this year in the amount of \$3500! Funds will continue to support the free battery and cell phone recycling here at the Board of Health. The increased funds this year will possibly give us the opportunity to provide additional services or perhaps another compost bin giveaway. Stay tuned.
