#### **MINUTES**

### **BILL SCANLAN**

Mr. Scanlan spoke briefly with the Board this evening to discuss lot sizes in the Village District. Current zoning calls for a minimum of 15,000 sq. feet for a single family dwelling while 2, 3 & 4 family dwellings require 40,000 sq. feet. When the zoning was initially established, the minimum requirements created many pre-existing, non-conforming lots. Mr. Scanlan provided a lot size analysis for review. In order to encourage redevelopment within the Village District, the Board is considering amendments to the current zoning. After a discussion, all were in agreement to begin a dialog with residents through a series of informational meetings. The Board will begin the meetings after the holidays and hope to present a proposal to the voters in May.
