COMMENTS & CONCERNS

Mr. Krawczyk advised all that CMRPC recently provided estimated figures for upcoming populations for the town. According to the Donahue Institute (part of UMass-Amherst), they have estimated the figures would increase the town's population as much as 15% in the next few years.

In addition, Mr. Scanlan has prepared a letter of support for the Board of Selectmen to sign regarding the Freight Rail Study. Mr. Scanlan will also check with the Highway Surveyor to see if he's interested in using our LPA hours for mapping of the town's catch basins.

6:15PM - PROPOSED ZONING AMENDMENTS/ADOPTIONS VILLAGE DISTRICT LOT SIZES

The Board is considering placing an amendment to the current zoning before the voters in May. The overwhelming majority of the lots in both Village Districts are non-conforming. By changing the demential requirements, the opportunity is there to expand a structure without having to apply for and obtain a Special Permit. The change will not necessarily increase growth, as the build out is already close to maximum. Further discussions will take place at future meetings. Informational meetings will also be scheduled. David Persky has contacted the office requesting that his property be included in the MCOD. When originally adopted, Mr. Persky opted out of his property being included. The Board is agreeable to place his property for inclusion in the MCOD on the warrant.

After a discussion, the Board was in agreement to have Mr. Scanlan provide a survey for the townspeople to complete to see if the residents are interested in moving forward with a bylaw. In the past, this topic has met with opposition.
