Discussion on properties on Devils Lane. The Office has been emailing Zach Lemieux, Highway Surveyor for the Town of Brimfield also Tom Boudreau, Town of Warren Highway Superintendent both Highway Bosses are both in agreement that Brimfield will continue to plow the Road as long as the owners of the properties continue to maintain the Road. We asked Mr. Lemieux what's an acceptable standard for a road is. One with out potholes, trees, rocks, ledge or any hazards that will cause damage to Brimfield Hwy Truck or equipment. Any brush or trees should be trimmed or removed. The gravel road should have a 2-4% crown to properly shed water, Ideally an 18' width or greater if possible. The Board was in agreement that we should come up with a form that both Highway Depts would sign off on before we would consider to approve the frontage for the owners to build on. Owners must maintain & repair the Road. Also check with Jack Keough (Building & Zoning Officer) to see what he will want.
