The Board received the finding from the AG (Attorney General) for the Open Meeting Law that Mr. Baril filed against the Board. The AG commended the Board for allowing the complainant to record the meeting but requiring the complainant to focus on the chair was not reasonable. The Board was cautioned that similar future violations could be considered evidence if intent to violate the law.

7:20pm- Continuation of the Public Hearing on Special Permit No. 46 for David Albrecht (Borrego Solar Systems, Inc.)

The Applicant has been working with The Conservation Commission with concerns Conservation had with the original Plans with the wet lands. Conservation closed their Hearings on May 9, 2018 with Mr. Albrecht. Monday, May 14, 2018 the Conservation Commission sent the Board their Orders of Conditions.

The Applicant made the changes and submitted the New Plans to the Board. Mr. Albrecht showed the Board where the changes were on the New Plans.

The applicant was requesting to construct and operate a 5,061.600 KW ground-mounted solar energy facility. The New Plans the Facility has been scaled down to 3,810.24 KW Ground Mounted PV Facility. The property is located at 355 Cronin Rd also know as Assessor's Map 10 Lot 74 which is located in the Rural District. The property is owned by Francis R. Adley.
