Abutters have concerns with the Wavier Syncarpha has submitted to the Board to wave the 150 ft buffer. The consensus of the Board is they will not sign the Wavier.

Syncarpha has a lease to construct a drive way through lot 82 from the property owner. Mr. Blake property abuts lot 82. Mr. Blake question was why don't we have a buffer for the road ways. The answer was we haven't had this occur before. Mr. Blake is very concern with all the Trucks and Noise in and out of the road so close to their Home.
