Ernest Mello for ZPT.

On March 25, 2019 Mr. Mello addressed the Board asking to withdraw the Special Permit Application and continue with Site Plan only. (This was part of the Lawsuit). The Board inform Mr. Mello that we have 30 days to decide to appeal.

The Board unanimously decided not to appeal the decision from the Court. The Board did not want the Town to occur anymore legal fees.

The Board wants the amended compliant dismissed also.

Mr. Kiritsy, Esq. said he did not file the amendment in the court. Mr. Ramsey will call Town Counsel in the morning to see if it was filed.

Board will continue as is till answer from Town Counsel.

Comments & Concerns

Mr. Boudreau Highway Superintendent and Abutters have concerns with the culvert on the north side backing up all the time.

Any staging would have to be on Rt 67. One truck up at a time and one down at a time. Because of Milk Trucks and School Buses.

Have a Police Officer or Flagman on duty while the driveway is being constructed and for deliveries.

Wants the road to be sweep daily.

Will a tub grinder be on site? Mr. Mello answered they will be taking the large logs and stumps off site. The rest will be chipped on site.

Angle into the site with the soft shoulders on the road.

Mrs. Richardson asked why haven't they used Worcester County Soil Maps? Mr. Skoultchi answered they did test pits, had site data and was Peer Reviewed approved from two (2) engineers.

At this time motion was made to continue Hearing to April 22, 2019 @ 7:45 made by Mrs. Sepanek: second Mr. Veliz- 4 Yes Votes- 1 Recuse (Mr. Ramsey)

Reviewed Proposed Zoning Bylaw Amendment received by the Warren Solar Advisory Committee.

Mr. Ramsey had no changes. Mr. Ramsey did ask if Mr. Keough had an opinion. Mr. Keough did and the committee made the changes he suggested.

Mrs. Sepanek was fine with the amended bylaw as long as Town Council approved.

Mrs. Libby asked if the amendment gets voted in what will the State say? Most of the changes they have made other Towns have already made and have been approve by the AG's Office.

Mr. Souza had two concerns #1 is restricting zones but won't object because of what is happening to the Town. #2 Why only allow 18 projects in town. If all projects on the table now get approved it would allow for two more in Town.

Mr. Souza & Mr. Veliz, Thanked the Committee for their hours of hard work putting together the proposed amendments.

The Committee has the Boards support.
