Meeting was called to order at 7:15 PM

7:15pm- Continue Public Hearing for Special Permit No. 290 Site Plan No. 58 for Eric & Linda Esiason. The Applicants are requesting to use up to three (3) accessory building as an extension to the existing 'Bed & Breakfast' as a Family Campground.

The Chairman asked if the Board had any concern or any question they wish to ask. The Board had no further questions. The Applicants were asked if they under stood they would need permits from the Board of Health and Building/ Electrical Inspectors. The Applicants under stood they will need all necessary Permits. With no further question the motion was made.

7:30pm-Continue Public Hearing on Special Permit No. 281 & Site Plan No. 49 for Syncarpha Capital LLC. The Applicant is requesting to construct and operate a 4.98 MW Ground-Mounted Solar Energy Facility. The Property is located on Little Rest Rd. also known as Assessors Map 11 Lots 82 & 83.3 which is located in the Rural District.

New Documents Submitted are Revised Stormwater Basins (dated 1/17/2019), Table 3.2.2.1 Stormwater Peak Rate Summary and Table 4.2.2.1 Stormwater Peak Volume Summary

The Storm Basin was changed to an Infiltration Basin. Mr. Walsh found no issues with the new Basin. A question was asked at the prior meeting about having more basin to slow the water down. Graves answered having one large basin would act the same as having 5 smaller ones.

Question was asked what happens over time to the Basin. Syncarpha will have cameras monitoring (24/7) the Basin and the Swales to insure they continue working properly for the first two years. The Basins are designed to drain within 72 hours, they will mobilize if they don't to inspect, clean and repair if necessary. They will do an onsite inspection of the Basins & Swales monthly for the first two years also, after a major rainfall event (>I inch) for the first two years. Add a Maintenance Bond for monies (25,000.00) to fix any issue that may happen to the Basin and Swales.

Mr. Souza want the Street swiped on a daily basic. (question asked at prior meeting) As a condition to the Stormwater Pollution Prevention Plan (SWPPP) they have to clean any dirt from the public road. The Board could put this as a condition.

Concerns with the Storage Battery Boxes. Syncarpha will add a third containment under the Boxes.

Mr. Veliz asked if they would consider having a web-site for the Towns People to monitor the project. Syncarpha said yes, they have done this in other Towns.

Mr. McCann added what the benefits to the Town are.

Net metering up to \$60,000.00 per year. (split between Town, local businesses and residents)

\$45,000.00 in Tax dollars per year.

\$40,000.00 Scholarship (10,000.00 per year for 4 years).
