# BOARD OF SELECTMEN MINUTES OF APRIL 6, 2016 SHEPARD MUNICIPAL BUILDING

Chairman Nardi called the meeting to order at 4:37 PM and dispensed with the Pledge of Allegiance in the Selectmen's Meeting Room in the Shepard Municipal Building.

Chairman Nardi announced the meeting was a work meeting between the Selectmen and members of Finance Committee.

# Budget FY 16 Discussion(s)

Igor Kuprycz addressed the Selectboard with a request to consider an increase in the FY 16 cap on the EYE ½ revolving account for Cable Access. Due to increase in staffing and a replacement computer the Cable Advisory Committee will have a shortfall. Request is made to increase the cap by \$5,000.00; following a brief discussion, Motion to increase the cap to \$25,000.00 for FY 2016, made by Mr. Gagner; second: Mr. Nardi.

#### Budget FY 17 Discussion(s)

Mr. Nardi would like to review the department budgets; followed by the article intentions for the upcoming Special and Annual meetings. Discussion was had on the following budgets as presented in the handout. (Attached to the end of these minutes) - \*\* Budgets approved by the following : Motion to approve [department budget] approved by the Finance Committee on the 24<sup>th</sup> of March and as recommended by the Finance Committee in the amount of [amount]

\*\*Selectmen's Total: M: \$1,526,206.00, by Mr. Nardi; second: Mr. Gagner – (2-0) includes increase to hydrant rental Prec. B previously considered, most significant increases were in retirement assessment; and the multiple insurances.

\*\*Finance: M: \$41,000.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\*Accountant: M: \$73,580.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

Assessors: Motion to approve @ \$89,447.00, by Mr. Nardi; second: Mr. Gagner – (2-0); does not include FinCom's reported \$1000.00 stipend

Treasurer: Motion to approve @ \$72,861.00, by Mr. Nardi; second: Mr. Gagner – (2-0); does not include FinCom's reported \$4,000.00 stipend

\*\*Collector of Taxes: M: \$71,339.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\* Planning Board: M: \$12,233.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\* Conservation: M: \$8,786.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\*Building Inspector: M: \$26,988.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

Town Planner: Motion to approve @ \$34,430.00, by Mr. Nardi; second: Mr. Gagner – (2-0); prior discussion with Planning Chair and Town Planner; agreement to change to per diem, recommend keeping same appropriation.

\*\*Forester: M: \$24,000.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\*Veteran's Agent: M: \$104,100.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\*Cemetery: M: \$26,540.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\* Board of Health: M: \$32,294.00, by Mr. Nardi; second: Mr. Gagner – (2-0); includes increase of \$250 for each Board member.

\*\*Council on Aging: M: \$93,531.00, by Mr. Nardi; second: Mr. Gagner – (2-0); includes new line for \$2,000 for equipment maintenance. Mr. Nardi will reach out to Kitteridge to visit Center and make recommendations for possible upgrades.

\*\*Library: M: \$156,742.00, by Mr. Nardi; second: Mr. Gagner – (2-0)

\*\*Parks: M: \$48,800.00, by Mr. Nardi; second: Mr. Gagner – (2-0) Mr. Mongeon explained the re-alignment to the various line items to reflect salary/wage vs. expenses, per review with Town Accountant. FinCom does not recommend requested increase in Commissioners salary.

Highway: there was discussion on the various line items; Mr. Mongeon suggested a tentative approval on the budget; with the understanding there may be an adjustment to the wages due to correcting calculations. Mr. Mongeon will work with Town Accountant on this. Both Boards are in agreement to accept requested increase in Machine Maintenance; level fund resurfacing & general highway. Motion to tentatively approve budget @ \$501,445.00 by Mr. Nardi: second: Mr. Gagner (2-0)

Fire: Mr. Gagner abstained from discussion. Discussion was had on increases to ambulance payroll; Chief's contractual certification increase. Note: on March 17<sup>th</sup>, there was a consensus of the Board to approve this budget (Mr. Lavash/Mr. Nardi) Given that Mr. Lavash is absent, Mr. Gagner has abstained Mr. Nardi evoked the rule of necessity and entered a Motion: M: \$400,656, by Mr. Nardi; second: Mr. Nardi (Gagner –abstained) Police: Discussion was had on the salary and overtime lines due to shift in personnel. Police school was re-aligned with salaries. Communications, although a recognized union, Finance considered based on wage adjustment scale. Noting there may be some adjustments to come, Motion to accept Police budget @ \$881,043.00 by Mr. Nardi; second: Mr. Gagner (2-0)

\*\*Town Clerk: Mr. Mongeon noted that request in increase due to changes/mandates to Elections/Registrations \$6950.00 was given a new line to denote it is specifically for Presidential elections every four years. Discussion was had on the clerical salary line. Mr. Mongeon explained that several years ago, one clerical position served both Town Clerk and Tax Collector. Upon retirement of individual, that position split between to two positions at 15 hours for each department. The clerical position for the Clerk, however, continued to be calculated at the higher wage for those 15 hours, not at the lower wage for newly hired clerical individual(s) thus the line has continuously been overfunded and spent to pay the position more than the hours allotted - at the discretion of the Town Clerk. FinCom's recommended figure allows for the correction of wages & hours as has been done with all other departments.

- **1.** To see if the Town will vote to authorize the Board of Health members to be paid \$10.00 an hour for providing coverage for clerical duties and to cover office hours as needed
- 2. That the Town amend the Town's General By-Laws, Article IX, Use of Public Ways and Places, <u>Section 12: Sanitary</u> Landfill as shown on Attachment #1,

1. \$44662.00 for the purchase of a fully marked police SUV patrol unit with in-car video recording.

#### Friends of the Town Hall

To see if the Town will authorize the establishment of a Stabilization account for the Warren Town Hall Mr. Nardi noted would require 2/3 vote in and vote out. Thanked FOTTH for their fundraising efforts, however those monies would not be added to this fund. Mr. Gagner is personally against using town money, but will let voters decide.

Motions to include the above articles on the Annual Town Meeting Warrant, by Mr. Nardi; second: Mr. Gagner – unanimous.

#### Articles for Park & Rec:

 \$11,000.00 to fund the costs of the purchase, display and any associated expenses for fireworks for the Town's 275<sup>th</sup> Birthday Celebration

#### Articles for Highway:

1. \$200,000 for the purchase of a new roll off dump/plow/spreader/catch basin/ truck. See attached description:

Motions to not include the above articles on the Annual Town Meeting Warrant, by Mr. Nardi; second: Mr. Gagner – unanimous.

There was considerable discussion on the School Department budget. Their request is for \$488,925.00 as the above minimum contribution. The Selectboard is putting forth \$225,000.00 for FY 17 above minimum contribution. There was discussion as to implications of the higher amounts to the tax rate and possible position of West Brookfield. Finance members contributed information on figures for transportation, school choice and teacher/admin staffing. There was mention of the importance of resident participation at the Town meeting and to be informed when making the fair and right decision.

Mr. McKeon inquired about his proposal for a stipend for the Emergency Management Director. Mr. Nardi noted that the request suggests the creation of a new position; which would not be appropriate at this time given that the Board has not had the opportunity to formalize a job description and meet with both Chiefs to see how best to meet the needs of the Town. Mr. Mongeon cautioned that Mr. McKeon seeking compensation for training while in what has arguably always been a volunteer position, could cause problems as other volunteer groups/boards pursue training without compensation. Finance Committee does not support funding at this time; they would consider if perhaps the possible new position was incorporated within the Police and or Fire Departments. Mr. Nardi noted that the Board would take up the matter during the summer.
