PARK & RECREATION

Motion to approve the FY 18 Budget request in the amount of \$48,900.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

HIGHWAY DEPARTMENT

After a discussion with the Highway Surveyor, the following motion was made: Motion to approve the FY 18 Budget request in the amount of \$519,768.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

COUNCIL ON AGING

Motion to approve the FY 18 Budget request in the amount of \$93,794.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

FIRE DEPARTMENT

Based on recommendations by our Auditors, portions of the salaries have been broken out therefore the following motion was made: Motion to approve the FY 18 Budget request in the amount of \$442,686.00 made by Mr. Richard; second: Mr. Nardi 2 Yes, 1 Abstention (Mr. Gagner)

POLICE DEPARTMENT

The Board, Finance and Police Chief have met several times to discuss the department's FY 18 budget. With the new CBA in place for the dispatchers and the mandated retirement of the Sergeant, the salaries lines were discussed. The overtime for the officers was also a point of discussion. After a lengthy discussion, all were in agreement to meet again and discuss on a final number.

In light of the state mandated Records Access Officer and the duties and responsibilities it entails, the Board of Selectmen have made that position as an addition to the Administrative Secretary's responsibilities. Motion to approve the FY 18 Budget request in the amount of \$50,520.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

SELECTMEN C

Motion to approve the FY 18 Budget request in the amount of \$258,765.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

Motion to approve the overall Selectmen's FY 18 Budget request in the amount of \$426,234.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

BENEFITS

Motion to approve the FY 18 Budget request in the amount of \$1,193,048.00 made by Mr. Gagner; second: Mr. Richard – unanimous.

QUABOAG REGIONAL SCHOOL DISTRICT

After a discussion the Selectboard made the following motion: Motion to approve \$396,482.00 above minimum for FY 18 made by Mr. Nardi; second: Mr. Richard – unanimous. *Finance Committee passed over this department as they will be meeting again to discuss their recommendation.

SPECIAL TOWN MEETING WARRANT

After a review and discussion on housekeeping matters, the following motion was made: Motion to approve and sign the Special Town Meeting Warrant as presented made by Mr. Gagner; second: Mr. Richard – unanimous.

ANNUAL TOWN MEETING WARRANT

Chairman Nardi requested that all of the boiler plate Articles be placed at the beginning of the Warrant. The members agreed. The only other discussion was on the following:

Article 18 – Recommendation from Counsel based on the Municipal Modernization Act.

Article 24 – Request for \$40,000.00 for window replacement at the Town Hall. Mr. Nardi motion to place Article on Warrant and Mr. Richard seconded. Mr. Gagner voted NO. Motion carries.

The Articles for Highway were voted as follows: \$93,000.00 (purchase of new trackless) and \$12,000 (repair of existing trackless) Motion made by Mr. Gagner; second: Mr. Richard – unanimous.

Motion to Adjourn made by Mr. Gagner; second: Mr. Richard – unanimous at 1:05 PM.
