#### WARRANTS & INVOICES

Motion to approve and sign Warrant No's. 36 & 37 dated October 30, 2017 in the amounts of \$40,073.73 and \$53,071.61 respectively made by Mr. Nardi; second: Mr. Richard – unanimous.

### WARREN PUMPS, LLC TIF AGREEMENT

At the request of the Board of Assessors', the Board confirmed the vote that was taken on August 3, 2017 reaffirming the unanimous decision to decertify the Warren Pumps, LLC's TIF Agreement effective Fiscal 2018.
