MINUTES

Motion to approve the Minutes of June 21, 2019 as written made by Mr. Richard; second: Mr. Nason – unanimous.

CORRESPONDENCE

- 1. The office received a letter from residents of Brookfield Road citing their concerns over a proposed solar project. The office also received several emails from residents echoing their concerns with regard to solar.- *Noted*
- 2. The office also received correspondence from residents of Town Farm Road regarding the persistent noise from the Palmer Racetrack. The residents are urging town officials to take action. –Noted. The office did contact the Town of Palmer and the matter is currently in litigation. Mr. Richard further reminded all that the tract is not located in our town so this Board's authority is limited.
- 3. The office received the monthly report of CERT/EM for the months ending May & June 2019 and the Police and Fire Chief's reports for month ending June 2019. *Noted and thank you.*

Mr. Nason will check to see if there are any bikes worth saving prior to the donation.
