There is sufficient number of checklist names on the petition and it has to by law be placed on the warrant. The Selectmen investigated the petition complaint, against the Chief, which states that he is not performing his job. The Selectmen found that he has done his job and much more for the Town and the Selectmen are unanimously in support of the Chief.
