3.0 BUILDING AND PARKING PERMITS

- **3.1 Edward and Jane Thayer: TM# 9-061,** 12x30 shed to store wood. Eaton had inspected and found that all of the setback requirements had not been met. - **3.2 Victor and Jen Pepin, TM#14-424, Ashuelot Acre Road,** provided a building permit to construct a 16x24 addition with a 5x15 new porch and 12x16 deck. After reviewing the application, the Selectmen determined that the setback requirements have not been met. Eastman motioned to deny the permit as presented. Marshall seconded the

motion. All voted in favor. The permit was denied and Dagesse will forward a Board of Adjustment application to the property owner.
