### **3.0 BUILDING AND PARKING PERMITS**

**3.1 Carolyn Lawson: TM#15-044, Faxon Hill Road**, requesting a permit for a 16x19.75 seasonal camp. Eaton had inspected and found that all of the setbacks were in accordance with the Land Use Ordinance. Eaton motioned to approve the application. Marshall seconded the motion. All voted in favor, permit #2493 was issued.

**3.2 Stephen Robey: TM#12-052, McLaughlin Road**, requesting a permit to construct a 24x28 garage on a slab. Eaton had inspected and found that the setbacks were in accordance with the Land Use Ordinance. Eaton motioned to approve the application. Marshall seconded the motion. All voted in favor, permit#2495 was issued.

**3.3 Frank Iosch: TM#14-183, Ashuelot Drive**, requesting a permit to construct a 90 square foot modification to an existing deck. Eaton had inspected and found that the setbacks are in accordance with the Land Use Ordinance. Eaton motioned to approve the application. Eastman seconded the motion. All voted in favor, permit #2494 was approved.

**3.4 Cecile Bushey: TM#20-081, East Shore Drive**, Eaton motioned to approve the application of Bushey for a parking permit. Marshall seconded the motion. All voted in favor.

#### **4.0 APPOINTMENTS DURING THE DAY AND PREVIOUSLY**

- 4.1** Richard Massicotte came in to get a driveway permit application. Dagesse provided him with one.
- 4.2** Kevin Belanger, representing the APDVD, phoned to ask permission to use a portion of the Town Hall on July 28<sup>th</sup> for an APDVD meeting. The Selectmen authorized the request.
- 4.3** Paul Carmichael came in to the Town hall and Eastman provided him a tour.
- 4.4** Van Hertel, Wayne Burgess and the Selectmen reviewed the town maps and the Town forestry property on Old Marlow Road. A current use bill was issued to Mr. Burgess, which he has not paid yet until the issue is resolved. Hertel and Burgess said that they feel that the property does exist and went on to explain why. The Onella family put properties into current use but this property was not listed. Eastman said at this point the Town is asking the surveyor to go over the survey. Marshall said that there would be no further action regarding the current use bill until the issue has been resolved. There was discussion about the property coming out of current use and the fact that the acreage does not qualify. Marshall will discuss with the Assessor's next week.
- 4.5** Concerned citizen's had questions regarding when the cell phone tower would be erected. It looks like sometime the end of September mid October and another possible tower on the town public works garage property shortly thereafter.

#### **5.0 DEPARTMENT HEAD AND EMPLOYEE APPOINTMENTS**

##### **5.1 Kathy Atkins:**

**5.1.1.** Provided information on a property that a 911# is not posted and an occupancy inspection that must be completed. Dagesse to address.

##### **5.2 Ed Thayer:**

**5.2.1.** Informed the Selectmen that the Mill Street Bridge project is complete.

**5.2.2.** Informed the Selectmen that he is awaiting a waiver request from the State for the Faxon Hill Road culvert project. The State is requesting a larger culvert, which would make the project a bridge.

**5.2.3.** The Selectmen and Thayer discussed the speed limit on Millen Pond Road. The Selectmen informed Thayer to post 30MPH signs on both ends of the road and a cautionary 25MPH will be posted under the children in the road sign.

5.2.4. Reported that the Dole Schoolhouse Bridge project permit will be completed next week.

### **5.3 Sandra Eccard:**

5.3.1. Requested the Selectmen's authorization to move forward on tax deeding several properties in Town for non payment of taxes. The Selectmen signed the necessary paperwork.

### **5.4 Michelle Dagesse:**

5.4.1. Prepared a Quit Claim deed for the tax deeded property that was purchased last week. The Selectmen signed the deed and Dagesse forwarded it to the registry for recording.

5.4.2. Dagesse will come up with another round of bid lists for tax deeded properties that are coming up for sale.

### **6.0 Public Appointments:**

6.1 Phil Barker came in to speak with the Selectmen regarding comments on the classification of McKinnon Road. Eaton said that McKinnon Road is in LAE with Old Marlow Road below. Barker said that Old Marlow Road is not part of McKinnon Road and it is not under Ashuelot Drive or under the hill of McKinnon Road. Eaton said that it is in the area of McKinnon Road. McKinnon's sons are saying that the road is private all the way to the bridge and the Selectmen are stating that they cannot block the Class VI road. Barker asked if there was an agreement between the development and the Town. Eaton answered no. There was discussion regarding the classification of other roads in Town. Barker asked if the Selectmen found out what happened to the almost new flags that were removed from the cemetery. Barker said that his concern is that these flags were destroyed and they were perfectly good for use. Eaton said that there should be communication between the Patriotic Purposes members and the Cemetery Committee. Barker said that the Cemetery Trustees think it is disgraceful to have flags fallen down after winter. Barker asked if the Selectmen would find out where our flags went. The Selectmen agreed to ask the Patriotic Purpose Committee if the flags were still available for service and get back to Barker.

6.2 Berry came to report to the Selectmen that a girl from MA had gotten sick after swimming in Lake Ashuelot. It was determined that she got sick from goose excrement and not the water. Berry provided information to LAE Board and the summer church program, Berry provided the Selectmen with information on the symptoms that someone could get from swimming. There was only one case in the whole lake so he felt no need to post the lake for bacteria.
