3.0 BUILDING AND PARKING PERMITS

- 3.1 NNEC of Seventh-day Adventist: TM15-158, 121 King Street, proposed to construct a 20x40 restroom building. Eaton had inspected and found that the setbacks were in accordance with the Land Use Ordinance. Eaton motioned to approve the application. Marshall seconded the motion. All voted in favor; permit #2495 was approved.
- **3.2 Alan and Karen Gagnon: TM#14-266,** Pierce Road, requested that building permit #2384 be extended for an additional year with changes to dimensions of the addition. Eaton motioned to approve the request for an extension and the changes. Marshall seconded the motion. All voted in favor.
- **3.3 Michael Streeter: TM#12-035, Lovell Mtn. Road,** provided a building permit for a 6x16 deck. Eaton to inspect next week.

4.0 APPOINTMENTS DURING THE DAY AND PREVIOUSLY

- **4.1** Brad and Amanda Nyham came in to get information on town owned properties that are for sale. Dagesse assisted them with gathering information.
- **4.2** Carolyn Lawson phoned to ask if gutters would be included in a footprint. The Selectmen answered no.
- **4.3** Lloyd Condon came in to get a building permit application. (See 3.1)
- **4.4** Michael Streeter came in to respond to a letter he had received from the Selectmen regarding a cabin and deck on his Lovell Mountain Road property. Dagesse provided him with a building permit application. (See 3.3)
- **4.5** Eaton was approached by a concerned citizen regarding the speed limit on Millen Pond Road. Eaton reassured him the Selectmen have reinforced that the speed limit will be posted 30MPH with precautionary signs Slow Children at Play. The resident wanted the Selectmen not to post any signs. Eaton informed him the speed limit would be 35MPH without the suggested signs.
- **4.6** Eaton was phoned from a Long Pond Road resident inquiring on his neighbor and the condition of the roads. Eaton informed him that they are private roads.
- **4.7** Mr. Fauteux came in and got a parking permit application and Dagesse provided him with his new 911#.
- **4.8** Skip Moore spoke with Eaton about the siding job on the Town Hall and expressed his concerns and compliments. Eaton assured him on what steps the contractor is taking to get the most life out of the siding. Moore then complained about the

- need for an overlay and rocks on Valley Road. Eaton passed it onto Thayer.
- **4.9** Mrs. Johnson called about using the bandstand for a wedding on September 15th at 6PM. The Selectmen approved the request. Dagesse will contact Mrs. Johnson.
- **4.10** Steve Hodge spoke with Eastman asking about the progress of the RV situation. Eastman relayed the progress the Selectmen has taken and the subject will be going to the Planning Board.
- **4.11** Evie Boyce came in to ask Eaton for a letter regarding the flooding in 2005. Eaton wrote her the letter. Boyce complained about the culvert head near her property.
- **4.12** Sara Voorhes phoned to ask questions about renting the lodge. Dagesse provided her with the information and an application.
