#### TOWN WARRANT

#### THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Washington in the County of Sullivan in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Town on Tuesday, the eleventh day of March, next, at ten o'clock in the forenoon, to act upon the following subjects:

- Article 1. To choose a Town Clerk, Treasurer, One Selectman for three years, Road Agent, Tax Collector, Auditor, Member of Trust Funds Committee for three years, Member of Library Committee for three years, and all other necessary town officers.
- Article 2. To see what sum of money the town will vote to raise for the repairs of its highways and bridges for the ensuing year.
- Article 3. To see if the Town will raise and appropriate the sum of \$640.50 and accept State Aid of \$1,280.00 for construction of State Aid Road.
- Article 4. To see if the town will vote to raise and appropriate the sum of \$434.71 and accept State Aid of \$1.738.82 for construction of Class V Highways.

Article 5. To see what sum of money the Town will vote to raise and appropriate to defray Town Charges.

Article 6. To see what sum of money the Town will vote to raise and appropriate for the observance of Memorial Day.

Article 7. To see what sum of money the Town will vote to raise and appropriate for the support of Shedd Free Library.

Article 8. To see if the Town will vote to instruct the Selectmen to borrow money in anticipation of taxes.

Article 9. To see what sum of money the Town will vote to raise and appropriate to assist the Band in putting on a series of concerts during the summer.

Article 10. To see if the town will vote to raise and appropriate a sum not to exceed \$100.00 to build a new, or repair the present, Tramp House, and furnish the same with adequate utensils.

Article 11. To hear the report of the rest room committee and see what action the Town will take, and appropriate sufficient money for same.

Article 12. To hear the report of the investigating committee on the method of preserving Town Records and see what action the Town will take and appropriate sufficient money for same.

Article 13. To see if the Town will vote to limit the Selectmen's salaries and expenses. Article 14. To see if the Town will vote to adjust the salaries of the Town Clerk, Treasurer, Tax Collector, Janitor, or any other Town Officer.

Article 15. To see if the Town will vote to raise and appropriate the sum of \$300.00 for the support of the Fire Department.

Article 16. To see if the Town will authorize the Fire Department to trade the present Fire Truck for a larger one.

Article 17. To see if the Town will vote to raise and appropriate a sum sufficient to purchase a portable fire pump.

Article 18. To see what sum of money the Town will vote to raise and appropriate for recreational purposes.

Article 19. To see if the Town will vote to raise and appropriate a sum not exceeding one one hundreth of one percent (1-100 of 1%) of the 1940 assessed valuation for town advertising in the Dartmouth-Lake Sunapee Region.

Article 20. To see if the Town will install a suitable warning signal each side of Cram's Corner.

Article 21. To see if the Town will raise and appropriate the sum of \$1,689.48 to defray the cost of street lighting.

Article 22. To see if the Town will take any action in regard to sending our Police Officer to Police School at Durham for one week of free training and pay expenses while there.

Article 23. To see what action the Town will take in regard to property received by the Town through Tax Collector's Deeds.

Article 24. To see if the Town will accept the sum of \$100.00 and perpetually care for the Mason H. Dole lot in the Washington Center Cemetery.

Article 25. To see if the Town will accept the sum of \$100.00 and perpetually care for the Joseph Clark Jones and Frank Morrill lot in the East Washington Cemetery.

Article 26. To see if the Town will accept the sum of \$1,000.00 and care for the Wallace W. Dole lot in the Washington Center Cemetery according to the provisions of the trust.

Article 27. To transact any other business that may legally come before this meeting.

# REPORT OF FIRE CHIEF

The year of 1940 has proved to be a valuable one for our Department, although we have had very few calls and no serious fires we have gained much in an educational way.

During the late spring, members of the department attended classes sponsored by the State Board of Education and New Hampsihre Fire Chief's Club, at the Claremont Fire Station. The course included training in use of all types of fire equipment and first aid. The following members completed the course and received certificates: W. D. Otterson, Jr., W. D. Otterson Sr., Fred Otterson, Glendon Crane, E. R. McGrey, and Abner H. Barker.

By vote of the department, all fires excepting forest fires, of less than two hours duration, are fought without charge to the town.

Last spring the department bought the outside fitting for the 2½ inch pipe which Dr. Lindquist installed in the large well under his barn; making a large supply of water available in the center of the village.

On June 19th the Fire Department entertained the Grafton-Sullivan Forest Fire Wardens Association. The supper served, netted the department \$12.46. It is interesting to note that Washington has a greater membership in the association than any other town.

During the summer, on recommendation of the Fire Department the town bought a pair of helper springs and six fire extinguishers; two of which are of the Foamtype and are kept on the truck.

During the year the Fire Department has sponsored card parties, dances, a supper, and a show which netted them \$53.87.

At the present time we are working on a survey and maping the town locating all buildings and water supplies.

Our experience this year has brought out very pointedly the inefficiency of our equipment, chiefly the truck and pump. The personnel of the department is striving to be an efficient asset to the town, but needs efficient equipment to work with. As was cited last year ,our truck is much to small and investigation during the past season shows we can trade our present truck for one of the same year but of 1½ ton rating in a longer wheelbase which would be much more suitable for our needs, without cost to the town.

Our pump, a 75-gallon rating, is designed for pumping through only 500 feet of hose. The ideal pump best suited to our needs is a 150-gallon portable pump which many of our firemen have seen in operation and know its superior performance.

At the February meeting of the Fire Department, it was voted to have a telephone installed at the Fire Station.

In closing I wish to express my appreciation to each member of the Fire Department and others who have co-operated during the past year.

# REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board and the Citizens of the Washington School District:

Herewith I submit my sixth annual school report for your consideration.

The following pupils are to be commended for having maintained perfect attendance during the school year 1939-1940, for the number of periods indicated. The school year consists of thirty-seven weeks divided into four periods. Center School: Ruth Cornell, two periods; Murray Gray, two periods; Wayne Gray, the entire year, excellent; Ruth Johnson, one period; Eunice Ramsey, one period; Sarah Ramsey, one period; Clinton Cornell, one period; Sydney Rollins, three periods, good; Ruth Watson, one period.

Dole School: Donald Crane, two periods; Mildred Crane, two periods; Robert Crane, two periods; Ruth Day, one period; Dorothy Duefield, two periods; Gloria Woodrow, the entire year, excellent; Hazel Woodrow, the entire year, excellent; Lilla Woodrow, three periods; Robert Duefield, one period.

# General Discussion

Provision should be made for a nearer source of more abundant water for both schools. Neither of the two schools is sufficiently provided with water either for drinking or washing purposes. Both schools should be provided with sinks and water boxes over them so that the children may wash in running water. At the present time the children of an entire school use the same wash basin. This everyone in Washington knows is not sanitary. The problem of enough drinking water, and washing facilities is as old as the one room school in New England. The time is now ripe to take some progressive measure at some district meeting in the near future.

Progressive measures should also be taken to get rid of the old fashioned toilets handed down from earlier periods in our history. The toilets now in use are too cold to use with comfort in the winter, and besides they do not meet present day standards of sanitation. The more progressive one room schools use septic toilets which are satisfactory where running water does not exist. Septic toilets give out no odors, and do not freeze in the winter. When once installed all the care which they need is the pouring in of a pail of water a day. Such toilets were installed in the West Deering school two years ago, and on the basis of the good results secured there I feel safe in recommending them for Washington.

Many people think that good teachers are plentiful and that all we have to do is to go out and hire them. The school board and the superintendent know that this is not so. One room schools in particular have difficulty in securing desirable teachers. We were fortunate to secure the services of a successful experienced teacher for the Dole school, and a good beginner for the school at the Center. Let us do our best to keep satisfactory tachers indefinitely. A yearly turnover does not do the children any good. The attitude of the community in general towards the teachers has as much to do with their staying on, as does any other consideration.

The schools are doing more than just teaching the fundamentals. A great deal is being accomplished in the way of citizenship, health, guidance, games, and appreciation of patriotic and religious holidays, and for the social life of the schools, all aiming at laying a truly American cultural background and way of life.
