TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Washington, County of Sullivan, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the town hall in said town on Tuesday the ninth day of March next at ten of the clock in the forenoon, to act on the following subjects:

Article 1. To choose a Town Clerk, Treasurer, One Selectman for three years, One Selectman for two years, One Selectman for one year, Road Agent, Tax Collector, Auditor, One Member of Trust Fund Committee for three years, One Member of Library Committee for three years, Overseer of the Poor, Police Officer, Fire Chief, and all other necessary town officers.

Article 2. To see what sum of money the Town will vote to raise and appropriate for the repairs of its highways and bridges for the ensuing year.

Article 3. To see if the Town will vote to raise and appropriate the sum of \$428.37 and accept State Aid of \$1713.48 for the construction of S.A.C. road.

Article 4. To see what sum of money the Town will raise to defray Town Charges for the ensuing year.

Article 5. To see what sum of money the Town will vote to raise and appropriate for the observance of Memorial Day.

Article 6. To see what sum of money the Town will vote to raise and appropriate for the support of Shedd Free Library.

Article 7. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

Article 8. To see if the Town will vote to raise and appropriate the sum of \$250.00 for the maintenance of the Fire Department and reappropriate the balance of \$16.95 from the 1942 appropriation for the purchase of Knapsack Pumps.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$1,640.40 to defray the cost of Street Lighting.

Article 10. To see what sum of money the Town will vote to raise and appropriate for the control of Blister Rust.

Article 11. To see if the Town will vote to exempt from taxation all residents serving in the armed forces.

Article 12. To see what sum of money the Town will vote to raise and appropriate for building a new observation post suitable to be moved and use as a tramp house after the war.

Article 13. To see what action the Town will take as to use of \$105.68 obtained through sale of scrap.

Article 14. To see what sum of money the Town will vote to raise and appropriate, to completely overhaul the tractor.

Article 15. To see if the Town will vote to authorize the Selectmen to administer or sell any real estate acquired through Tax Collector's Deeds.

Article 16. To see if the Town will vote to have an audit made by the Division of Municipal Accounting and make an appropriation to cover same.

Article 17. To see if the Town will vote to raise and appropriate the sum of \$300.00 to purchase the gravel bank at the Thissell place.

Article 18. To see if the Town will vote to accept the sum of \$100.00 (Trust Fund) from the estate of E. E. Young, the income only to be used for perpetual care of the E. E. Young lot in Washington Center new cemetery.

Article 19. To see if the Town will vote to accept the sum of \$100.00 (Trust Fund) from George Young, the income only to be used for perpetual care of the George Young lot in the Washington Center new cemetery.

Article 20. To see if the Town will vote to accept the sum of \$65.00 (Trust Fund) from Herbert W. Rainie, the income only to be used for perpetual care of the Edwin Nichols lot in the East Washington cemetery.

Article 21. To transact any other business that may legally come before this meeting.

I hereby submit my first annual report as superintendent of schools.

PUPIL DATA

The following pupils were graduated from the

Washington schools in June, 1942. Henry Daigle, Mary Day, Ella May Young, Mary Ellen Young. I am pleased to be able to state that they are all attending high school.

The following pupils maintained perfect attendance during the school year 1941-42 for the terms indicated. For the consideration of attendance, the year is divided into four equal periods: Robert Crane, three periods; Henry Daigle, three periods; Ruth Cornell, two periods; Jean Crane, two periods; Sally Woodrow, two periods; Donald Crane, one period; Harry Drew, one period; Anna Paro, one period; Walter Perrault, one period; Lilla Woodrow, one period.

In September 1942 seven pupils were enrolled at the Center School. Since then three have left and one has entered making a total of five at the present time. The Dole School opened with thirteen pupils all of whom are still enrolled there.

GENERAL REPORT

We are in the midst of a terrific struggle involving nearly every human being on the face of the globe. Our one primary objective is, and must be, to win this war. Our second objective must be to properly train our children so that they will be able to assume their duties as citizens in a war weary world when peace has been declared.

These two considerations are constantly in our minds when we are thinking of education in our schools today. Washington school children certainly are doing their part in the war effort. Washington Center School received nation wide publicity be-

cause of the large amount of scrap they collected during the fall drive, being the highest amount, per pupil, of any school in the state. Besides this all our pupils have been buying war savings stamps, making posters and doing other things to assist in winning the war.

In the field of training a new emphasis is being placed upon the "three R's". No person can lead a successful life without the necessary training in these three subjects, reading, writing, and arithmetic. To these we are adding a fourth "R", that of responsibility. Too often in recent years people and children have both talked glibly about their rights but have failed to consider that for every right there is a corresponding responsibility or duty. We hope the citizens of tomorrow will be trained to accept their duties as well as demand their rights.

Hot noon lunches have been served the pupils this winter with the assistance of food given by the government.

One problem has bothered us a great deal this winter. After every bad snow storm the roads remain unplowed for several days with the result that several pupils have missed a lot of school this year. Perhaps there is no solution to this but it seems too bad that some pupils are denied the full privileges which others enjoy.

An extreme shortage of teachers developed last summer which has been growing increasingly more evident. The problem is worse among rural schools for most teachers do not care to teach in them. Up to the present Washington has been very fortunate in obtaining the services of two experienced teachers.

The pupils at the Dole school have no suitable place to play. If something could be done about this I feel that conditions would be greatly improved. This school also needs a source of water supply.

In conclusion I want to thank the school board, teachers and pupils for their cooperation in trying to establish and maintain good schools in Washington.
