TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Washington in the
County of Sullivan in said State, qualified to
vote in Town Affairs:

(L. S.)

You are hereby notified to meet at Town House
in said Town on Tuesday, the 12th day of March,
next, at ten of the clock in the forenoon, to act upon
the following subjects:

Article 1. To elect a Town Clerk, Treasurer, One
Selectman for three years, Road Agent, Tax Collec-
tor, Auditor, Member of Trust Funds Committee for
three years, Library Committee, one member for
three years, and all other necessary town officers.

Article 2. To see what sum of money the town will
vote to raise for the repairs of its highways and
bridges for the ensuing year.

Article 3. To see if the town will raise and appro-
priate the sum of \$673.50 and accept State Aid of
\$1,346.00 for construction of State Aid Road.

Article 4. To see if the Town will raise and appropriate the sum of \$437.86 and accept State Aid \$1,751.46 for construction of Class 5 Roads.

Article 5. To see what sum of money the Town will vote to raise to defray Town Charges.

Article 6. To see what sum of money the Town will vote to raise for the observance of Memorial Day.

Article 7. To see what sum of money the Town will vote to raise for the support of the Shedd Free Library.

Article 8. To see if the Town will vote to instruct the Selectmen to borrow money in anticipation of taxes.

Article 9. To see what sum of money the Town will vote to raise to assist the Band in putting on a series of Band Concerts this summer.

Article 10. To see if the Town will vote to build a vault for the protection and preservation of Town Records and appropriate sufficient money for same.

Article 11. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired through tax collectors deeds, such authority to continue until revoked by some future Town Meeting.

Article 12. To see if the Town will vote to adjust the salaries of the Town Officers.

Article 13. To see what sum of money the Town will raise for Forest Fire expenses and pass any vote relating thereto.

Article 14. To see if the Town will vote to raise the sum of \$300.00 for Fire Department. Said sum to be turned over to the Fire Dept. Treasurer, who is to furnish bond.

Article 15. To see if the Town will raise the amount required to repair the belfry of the Town House, as reported by the committee in charge of the work, and authorize the Selectmen to borrow the necessary amount and pass any vote relating thereto.

Article 16. To see if the Town will set aside approximately 200 feet on that portion of Mellen Pond Road that adjoins Mellen Pond for a Public Beach and Recreational purposes.

Article 17. To see if the Town will vote to raise a sum not to exceed \$300.00 to have a portion of the beach in the above article prepared for bathing purposes by July 1, of this year.

Article 18. To see if the Town, until this article is modified or repealed, will authorize the Selectmen to accept Trust Funds for the care of Cemetery lots when tendered.

Article 19. To see if the Town will vote to accept the sum of \$100.00 and perpetually care for the Joseph Clark Jones cemetery lot in the East Washington Cemetery.

Article 20. To transact any other business legally coming before this meeting.

REPORT OF FIRE CHIEF

March to Jan. 27, 1940

During the past year much progress has been made towards more efficient fire protection in our town.

In the spring the Washington Fire Department was organized and has met regularly on the first Tuesday of each month. After the business meeting there are discussions of the town's fire dangers and needs. There are 18 members and we feel that our greatest immediate need is for a portable fire pump.

Through the whole-hearted and unselfish efforts of the members of the Fire Department the entertainments, sponsored by them, have netted \$95.75.

The sum of \$19.20 received from the Selectmen for our work at fires has been turned into the Department treasury. Out of the sum of \$114.95 we have spent for tools and equipment \$57.62.

At this time I wish to thank each member of the Department for his cooperation and interest during the past year and hope the good work will continue.

During the past year I put in 60 hours labor and charged 45 extinguishers.

There are at least 15 families that have no extinguishers and most of these are in the Dole District. There are three extinguishers which have been frozen rendering them useless.

The lack of extinguishers has been the greatest complaint and I believe each family should have one.

This winter, through the cooperation of our Road Agent, the road to the water hole in back of the Town Hall is being kept open for the first time since it's construction.

Our experience with the Fire Truck has brought our attention to the following disadvantages:

1. It runs to low to the ground.
2. It is not large enough for its load, with 2 men it carries 700 lbs. overload.
3. It is not large enough to carry a booster or chemical tank which are very essential for fast work especially in small fires.
4. There is no room to carry men.

The truck has been kept in my garage and rent paid only from Dec. 1, until April 1.

Herewith I submit my fifth annual school report for your consideration.

The following pupils were graduated from the Washington public schools in June, 1939.

There were no high school graduates in 1939.

The following pupils deserve honorable mention for having maintained perfect attendance during the school year 1938-1939 for the number of periods indicated. The school year consists of thirty-seven weeks, and is divided into four periods.

Center School: Mary Ellen Young, three periods; Ruth Johnson, three periods; Ruth Watson, one period.

Dole School: Donald Crane, one period; Mildred Crane, three periods; Gloria Woodrow, entire year; Hazel Woodrow, entire year; Leda Day, two periods; Robert Crane, three periods; Henry Daigle, three periods; Barbara Ladd, entire year; Louise Duefield, two periods; Robert Duefield, three periods; Mary Day, two periods.

General Discussion

The Dole and the Center schools opened last fall, the former with a membership of seventeen pupils, and the latter with a membership of twenty-four. Ten children at the Dole school come from Windsor. It is to the credit of the two districts that we can run the school jointly in peace and harmony.

The following pupils from Washington attend Hillsboro high school: Robert Dalphond, grade eleven; Warren Hayford, grade eleven; Walter Johnson, grade nine; John Leeds, grade twelve; Townsend Leeds, grade nine. Lack of transportation is still a drawback to some who would otherwise attend high school. Not counting the Windsor children there are thirty-seven children all told attending both elementary and high school.

Our school buildings have been considerably improved during the past few years. A few things however remain to be done. Sooner or later adjustable desk units like the ones at the Center school should be secured for the Dole school. The toilets should be replaced with Kaustine septic toilets. The

present toilets are not in keeping with present day progress. They require a great deal of care and are not sanitary. The ones recommended are decent and odorless at all times, and do not require periodic cleaning, which is considerable expense. It is not too much to expect that the schools be made as attractive and as efficient as the better homes of the community. All of which is not unreasonable when we consider that the children spend the greater part of eight years of their lives in the grades.

Gentlemen:

I submit herewith the report of an audit and examination of the accounts of the town of Washington for the fiscal year ended January 31, 1940, which has been made by this division. Schedules as hereafter listed are included as part of the report.

FINANCES

As indicated by Schedule A. Which is a "Statement of Indebtedness, Valuation and Taxes," the net debt of the town as of January 31, 1940, amounted to \$2,540.25. There were no outstanding bonds or long term notes. Outstanding temporary loans in anticipation of taxes amounted to \$6,000.00. Uncollected taxes amounted to \$2,712.32 and unredeemed taxes, \$674.11. The local tax rate for 1939 was \$3.40 per \$100 as compared to the average rate for the state in the same year of \$3.45.

Schedule B, "Statement of Appropriations and Expenditures for 1939," indicates a net overdraft of appropriations amounting to \$984.79. Total appropriations for this year, plus receipts and reimbursements amounted to \$13,068.89 which, compared to total expenditures of \$14,053.68, resulted in a net overdraft as indicated.

TAXES

The tax warrants of collector Fletcher for the levies of 1938 and 1939 were audited and balanced as indicated by the summaries shown in Schedules F, and E. Verification notices were sent to all parties whose names appeared on the collector's uncollected lists as of January 31, 1940.

Summaries of the tax sale accounts for the levies of 1936 and 1937 are included in Schedule H, and for the 1938 tax sale account in Schedule G. A detailed list of unredeemed taxes on account of the tax sales for the levies of 1936, 1937 and 1938 will be found in Schedule I.

SELECTMEN'S AND TOWN TREASURER'S

ACCOUNTS

Vouchers issued by the selectmen during the fiscal year ended January 31, 1940, were examined as were also the supporting invoices and road agent's pay rolls. The cancelled checks of the town treasurer, issued upon the orders of the selectmen, were compared with the vouchers and found to be in agreement.

The receipts of the treasurer were checked by source insofar as it was possible to do so. Totals of receipts and expenditures were verified. The treasurer's cash book balance as of January 31, 1940, amounted to \$1,484.34 which agreed with the reconciled bank balance as of this date. (Schedule C).

TOWN CLERK

The town clerk's motor vehicle and dog license accounts for the fiscal year were audited and found to be correct as shown by Schedule D.

All funds received by the town clerk on account of motor vehicle permits and dog licenses issued during this period were remitted to the treasurer with the exception of the fees for dog licenses which the clerk retains in accordance with the provisions of the law.

ROAD AGENT

The road agent's pay rolls were examined. The computation of these pay rolls was found to be correct and the signatures of individual employes appeared thereon. All payments made by the road agent other than payments for labor were supported by cancelled checks endorsed by vendors or by receipted bills. (Schedule J).

TRUSTEES OF TRUST FUNDS

The principal of the trust funds is deposited in savings banks, and all funds were accounted for by examination of the savings banks' books. A check of the receipts and expenditures of trust funds income was made, and the balance of income on hand at the end of the year verified.

LIBRARY TREASURER

The accounts of the treasurer of the Shedd Free Library were examined. All payments made during the fiscal year were properly authorized, and the treasurer's cash book and bank balance were in agreement as indicated by Schedule L.

SCHOOL DISTRICT TREASURER

The accounts of the school district treasurer were audited for the period from July 1, 1939, to January 31, 1940. All payments were made on order of the school board.

The treasurer's cash book balance as of January 31, 1940, amounting to \$757.52 was in agreement with the reconciled bank balance of like date. (Schedule K)

GENERAL

No irregularities or discrepancies were discovered in the accounts of any of the officials. Recommendations and suggestions as to minor changes in accounting procedure were made during the course of the audit and are not included in this report.

In accordance with Chapter 211, Laws of 1939, Section 31, a copy of this report or a summary of its essential features should be published in your printed annual report for the fiscal year ending January 31, 1940.
