Director Brideau updated the board on the ongoing activities of the Assessing office. (See attached) The board discussed the MassGIS program and clarified the benefits are for the whole state to share a common Location ID system for better 911 response and rather than printing out maps to submit with DOR documents, they would be able to look up the live data on their own.

Board discussion on Motor Pool and Assessing Department needs

The Facilities Director believes the motor pool can work. He is researching scheduling software for reserving the cars for appointments. Currently, there is no centralized scheduling system or key location. Director Brideau approached the Finance Director about putting in a capital request. He said it's up to the Facilities Director and he said there's no money in the FY17 budget for a capital request for a vehicle.

She asked the board to write a letter to the finance committee regarding the need for assessors to have access to a vehicle.

- D. Hill suggested the BOA to write a letter to the Town Administrator restating the actions Director Brideau has taken and to ask for assurances that the motor pool will support the needs of the assessing office.
- J. Brodie clarified that having a car is not in the job descriptions of anyone in the Assessor's office. He stated the job cannot be completed under the current situation. The letter should list all of the assessing office tasks that require a vehicle. J. Brodie stated he would draft a letter to begin the process.
