Ventress noted that the memo provided insufficient detail of why the taxes were uncollectable and that it was not signed under oath as required by MGL Chapter 59 §71. In addition, Z. Ventress commented that he identified anomalies within the towns' financial documents that he will address directly with the Town Administrator as a resident versus having the BOA address his concerns. J. Brodie voiced that the request was deficient but that the BOA was not rejecting the request rather returning it to the Collector for additional information.
- J. Brodie motioned that the BOA rescind its vote of 12/12/16 of the Tax Collectors request to abated uncollectible personal property tax based on a review of MGL Chapter 59 §71. Z. Ventress seconded. Vote unanimous
